No request for adjustment of earlier dues / outstanding amount with the Company in place of EMD shall be entertained.

Micro & Small Enterprises (MSEs) / PSUs / Government Undertakings and Co-operative Societies / Start-ups as recognised by Department for Promotion of Industry and Internal Trade (DPIIT) etc., may be exempted from submission of EMD as per extant Government policy.

Exempted Bidders may submit a duly signed Bid Securing Declaration accepting that if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bid document, they will be suspended for the Plant/Unit, for a period of six months, from being eligible to submit bids for contracts.

In case of EMD/BG, Bidder is required to submit the BG in prescribed format only (given at Annexure-4). The BG shall remain in force up to and including 30 days after the period of bid validity. Scan copy to be submitted along with the bid, whereas Hard copy BG to reach on following address within 7 days from date of tendering opening date.
