OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

Additional Terms and Conditions

1. All relevant documents as per MTF should be uploaded in legible form.
2. Tenderers must comply with all the directions of NIT and MTF.
3. In case of bidder/s claiming the experience as per clause 3(I), the certificate of experience should be submitted as per Appendix VI of MTF only. The award letter of the contract (for which experience is claimed) should also be invariably uploaded by the bidder.
4. Tenderers without the requisite experience may also participate in the bidding provided they furnish an undertaking/ willingness letter to furnish an additional performance guarantee in the form of

bank guarantee of 10% of the contract value in the manner specified in the MTF (**as per the PRO FORMA - I given below**). Further, as per the undertaking, in case of successful award of contract the additional BG must be submitted to this office.

5. Price bid of only technically qualified tenderers will be opened and the date of opening of price bid will be notified later through GeM portal.
6. The Tenderer should be registered with EPFO as an independent employer, having separate code number as required for an employer under the provisions of EPF and MP Act 1952 and the EPF Scheme framed thereunder.
7. Prospective bidders should have to obtain ESI code No. in notified areas and should comply with the directions.
8. **An undertaking in respect of declaration of near relative as per clause 15 of MTF should be invariably submitted at the time of bid submission by the bidder/tenderer. Information to be also provided in tender submission undertaking compulsorily. (as per the PRO FORMA - II given below)**
9. **'Tender Submission Undertaking' (Duly filled and signed by the tenderer) should be invariably submitted along with tender documents, during bid submission.**

Tenderer should have experience of Transportation obtained from Manufacturer/PSU/Govt.Dept./Public Ltd. Company/Private Limited Company dealing in the field of Fertilizer, Food grains, Cement, Sugar, Coarse grains or similar products.

10. **The tender is being floated in GeM portal which levies transaction charges & Annual milestone charges (as applicable) to be paid by the bidders/sellers, after awarding the contract. Therefore, the prospective bidders are requested to go through the terms & conditions of GeM portal and also FCI tender document scrupulously before participating in the bid.**
11. **For Handling & Transport Contracts, experience of either handling or transport or both but in respect of rake only shall be considered, as per clause 3(I) of MTF .**
12. **In case of an MSE bidder, it is instructed to compulsorily validate/link the UDYAM number in their respective GeM ID. Further, bidders are instructed to validate the MSE Purchase preference by clicking 'YES' option while bid submission.**
13. **The prospective bidders are advised to invariably attend the Pre-bid meeting either in person or through VC to clear their doubts/get clarification on the bid submission through the GeM portal registered service category. If the bidders are willing to attend the meeting through VC, it is requested to forward their details through e-mail to nelloap.fci@gov.in email ID 02(two) days prior to the scheduled pre-bid meeting, so as to enable us forward the VC link.**
14. Tenders should be uploaded/submitted through Government E-Marketplace (GeM) Portal at <https://gem.gov.in>. Manual bids/Hard copy of the tender documents will not be accepted. However the successful tenderer will have to submit the original hard copy of MTF duly signed on each page of MTF along with annexures/appendices duly attested on or before the date & time stipulated by FCI, failing which the EMD furnished by the Bidder is liable to be forfeited.
15. All the tenderers must ensure that they should fill in all the relevant columns and indicate their cho

ices by ticking/striking the relevant points as indicated in the NIT/Appendices/Annexures of MTF, sign all the pages of MTF/additional documents etc., and upload them, failing which the tender will be liable for rejection.

16. All the undertakings should be given separately in the prescribed formats/proformas as stipulated in the MTF.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
