(d) Any bid not accompanied by an acceptable bid security in acceptable format in a sealed envelope, shall be rejected by the Employer as being non-responsive. In case, the bid security is submitted as e-BG, bidder to submit the copy of e-BG either in separate sealed envelope or in the e-tendering portal.

(e) The acceptable format of Bid Guarantee (BG) towards EMD shall be as per following link only:
