1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. 1. Drawing shall be sent for approval within 15 days of receipt of purchase order. The valve drawings clearly showing the constructional details, material, dimensions and pressure testing details. Item shall be strictly as per approved drawings.

2. Material Test certificates (chemical composition & physical properties) and hydraulic test certificates (pressure testing) shall be furnished along with the supply.

3. Pre-despatch inspection by FACT / TPI arranged by FACT is required. Inspection charges shall be borne by FACT.

a. Verification of the manufacturer's original test certificate for conformity with the standard specified.
