1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### **TERMS AND CONDITIONS**

- Ø Participating bidders must have a registered office located within the state of Kerala and hold an active Goods and Services Tax (GST) number issued by the Indian government. A valid local office license under Kerala state regulations is also mandatory. Relevant supporting documents must be provided for verification purposes.
- Ø The bidder must hold GST registration in the same state as the consignee, which is also the jurisdiction of the bid-inviting authority. The GST certificate should reflect the name of the bidding entity. Bidders are required to provide proof of having monthly regular GST returns for the past three years.
- Ø Only Original Equipment Manufacturers (OEMs) or their authorized representatives are eligible to participate. If submitting the bid as an authorized dealer, a **Manufacturer Authorization Certificate specifically referring to this tender must be submitted.**
- Ø The OEM/Bidder should have a service centre in Consignee District. The service centre address should be provided in OEM Letter head.
- Ø All quoted products must be current models that are still in production and supported by the manufacturer. Bidders must confirm that no quoted items are classified as end-of-life and that manufacturer support is ongoing.
- Ø The OEM must maintain a functional service facility within the district where the consignee is located. The facility must be equipped to provide prompt maintenance and repair services. Complete details of the service facility must be included with the bid. Service support must be provided within 48 hours.
  - Ø Bidders should have been actively engaged on the Government e-Marketplace (GeM) portal for at least the past three years. Appropriate documents verifying this period of activity must be attached.
- Ø The bidder must acknowledge and accept the Additional Terms and Conditions (ATCs) of this procurement process. A signed letter on company letterhead, indicating compliance with the ATCs as defined by the buyer, must be submitted.
- Ø A declaration must be provided on the bidder's letterhead stating that the company has not been blacklisted or debarred from government or public procurement in the last five years.
- Ø Products offered must strictly conform to the technical specifications mentioned in the tender. Any variance from the required specifications will lead to disqualification during technical scrutiny.
- Ø The purchaser holds the authority to accept or reject any bids based on a comp

arative market analysis of the offered products.

- Ø The brands quoted must enjoy a good reputation, strong industry presence, and be recognized for performance, reliability, and quality. Preference will be given to brands with positive customer experiences and a substantial footprint in the market.
- Ø Bidders must show a proven history of supplying Smart TV systems from the quoted OEM to central/state government departments or PSUs in Kerala over the past three years via the GeM portal.
- Ø The bidder must establish a service mechanism within Kerala capable of addressing issues with the products within 24 hours of a reported breakdown.
- Ø An Escalation Matrix including contact phone numbers for service support must be submitted by the bidder or OEM.
- Ø If there is any deviation from technical or general requirements specified in the tender, bidders must disclose this explicitly in a technical deviation statement, which should accompany the bid submission.
- Ø The bidder must have completed at least three individual work orders of similar products, each worth ₹1 lakhs or more, from the quoted OEM/brand through the GeM portal. These must have been executed within Kerala.
- Ø Bidders must present a live product demonstration to the consignee on the scheduled date and at the location designated by the consignee. Failure to demonstrate as per schedule will lead to automatic disqualification.
- Ø Drivers and product should be in the public domain
- Ø OEM should have minimum at least 3 authorized service center in Kerala state. The address and the contact details of the same should be provided in the bid.
- Ø The Television smart operating system should be from the same OEM to ensure security, compatibility and OTT Apps Restriction.
- Ø If any clarification is required regarding the product specifications or quality, the seller/bidder must be prepared to demonstrate the product if necessary.

### अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and

conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
