### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

### Additional Terms and Conditions:

- (A) The remuneration to the engaged staff shall be disbursed by the agency into bank accounts of the engaged staff directly through cheque/RTGS/NEFT, after obtaining authorization from engaged staff.
- (B) The Contracting Agency will ensure payment by the 5<sup>th</sup> of every succeeding month to their employees provided to the K.V. Jawaharnagar's office/premises on satisfactory work/actual attendance of their employees as per the monthly remuneration without any deduction.
- (C) The contracting agency will compulsorily send its supervisor to the Kendriya Vidyalaya Jawaharnagar Premises on a monthly basis to supervise the work of the outsourcing workers
- (D) The Contracting Agency will submit the invoice along with proof of disbursement in triplicate after making the payment to the employees provided to the K.V. Jawaharnagar's office/premises on satisfactory work/actual attendance of their employees supported with the following documents: -
- (i) Details of disbursement made to the staff furnishing cheque/RTGS/NEFT details for each payment.
  - (ii) Proof of payment of statutory obligation such as EPF, ESI and any other applicable tax. Payment to the Contracting agency will be released within 15 days from the date of the receipt of the invoice.
- (E) **It is mandatory for the contracting agency to submit the attested copy of license obtained from the Home Department of States(Bihar) under PSARA act, for running the business of private security agencies, failing which the bid will be treated as disqualified/non-responsive.**
- (F) **The bidding agency/vendor must provide a list of at least double the number of outsourced staffs to be engaged. After a brief interaction/interview, the principal will select the manpower, ensuring that outsourced staff provided by the agency are physically active and fit. The engaged guards/security staff should meet the required height and weight standards as decided by the engaging unit.**
- (G) **The bidding agency/vendor should have experience working with at least five**
- Government / PSU institutions, and educational institutions other than KVs**
- /ROs/ZIETs.**
- (H) Once appointed, the outsourced staff should not be removed by the agency from service
- during the entire tenure without the consent of the principal and valid reasons. Conversely, the Principal should not remove any outsourced staff unilaterally, and the monitoring committee of the Vidyalaya shall be invariably con

sulted by the Principal before approaching the firm/agency for removal. Principles of Natural Justice, to the extent possible and expedient, shall be considered before removing an outsourced staff for valid reasons.

- (I) The Candidates/Manpower provided by the Contracting Agency shall be accepted only after scrutiny by KV, Jawaharnagar. Therefore, minimum three-four bio-data shall be made available against each slot in each category. The candidate may be invited for personal discussion also. No Conveyance or any other charges will be paid by K.V. Jawaharnagar. In case, none is found suitable then additional bio-data shall be made available by the Contracting Agency, promptly i.e. within 24 hours. The replacement of a Candidate on account of absence /unsuitability for KV, Jawaharnagar, shall be made within 24 hours.
  
- (J) The contracting Agency will be required to sign a contract with the Principal, Kendriya Vidyalaya Jawaharnagar (who is Indenting Office) as per the Model Contract enclosed for ready reference. The other terms and conditions specified in the Bid document and accepted bid will also form the part of the Model Agreement.
- (K) In case of any loss, theft / sabotage caused by/attribution to the personnel deployed, the KV, Jawaharnagar, reserves the right to claim and recover damages from Contracting Agency.
- (L) The antecedents of all the workers will be got verified from the police by the Contracting Agency and submitted to K.V. Jawaharnagar before deployment for work.
- (M) The Contracting Agency will deploy the man power, who are below the age of 60 years as well as physically & medically fit.
- (N) The K.V. Jawaharnagar shall provide a small guard room/space for security guards deployed by the Contracting Agency. No name plate of agency shall be allowed on the room and nobody will be allowed to stay in the office except the staff of Contracting Agency on duty.**
  
- (O) RECOVERY- Kendriya Vidyalaya Jawaharnagar shall have right to impose cash penalty on the agency or deduct such amount from its Performance security deposit in case of Kendriya Vidyalaya Jawaharnagar being put to any financial loss directly or indirectly by any act of commission on the part of agency.**

**(P) Notice of Termination of Contract: - The Contract can be terminated without assigning any reason giving prior one-month notice in writing.**

**अस्वीकरण/Disclaimer**

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
