OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. ### 2. Generic

### 3. Buyer Added Bid Specific ATC

1. Copy of Work Order/ Agreement (with detailed Scope of Work & SOR) and its Completion mentioned in B EC (Section-II) should be notarized and Certified by Chartered engineer.
2. Udyam registration certificate notarized and CA certified (in case of MSE bidder)
3. Audited financial statement of preceding three financial years. (Notarized)
4. Format F-10 in the letterhead of CA without any modification in GAIL's format with UDIN of CA.
5. Formats (duly filled F-1, F-2A, F-3, F-5, F-9 (in case inadequate Working capital), F13(Integrity pact),Form -II and Form-I (Declaration of Local content), Form-IA and Form IB & Form II to section-II (Undertaking for land border).
6. जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
