1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

### 1. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

#### 1. Generic

**OPTION CLAUSE:** The buyer can increase or decrease the contract quantity or contract duration as per scope of work at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to **25 percent**. Bidders are bound to accept the revised quantity or duration.

### 2. Buyer Added Bid Specific Scope Of Work (SOW)

#### Text Clauses

- **Statutory Compliance:** The Bidder shall abide by the provisions of all relevant and applicable statutory labour and other laws, rules, and regulations as applicable in the **State of Uttar Pradesh**.
- **Service Continuity:** Any strike, work stoppage, or obstruction of hospital services by the service provider in manpower shall be considered **gross misconduct and a material breach of contract**.
- **Administrative Rights:** The Competent Authority has the right to increase, decrease, or re-arrange service counters per administrative exigencies. During hospital expansion, requirements may increase based on actual needs and may be started in a staggered manner.
- **Wage Payment Mandate:** The Service Provider is mandated to pay its staff by the **7th of each month**. Payment of wages must **not be delayed** due to pending invoices or bill processing at the University.

#### Financial Requirements (EMD & PBG)

- **Payment Method:** EMD and E-PBG must be submitted via **RTGS/Internet banking**.
- **Beneficiary Name:** Finance Officer.

- **Required Proof:** Valid documentary evidence (GST registration, Rent Agreement, or Utility Bill) must be submitted.

### Contract Period

- **Total Duration:** Maximum of **three (03) years**.
- **Initial Award:** The contract is initially for **one (01) year**, renewable annually for up to two additional years based on performance.

### EMD Relaxation/Exemption

- **Eligibility:** Provided to MSMEs/Startups registered in U.P. strictly per **G.O. No. 23/2022/165/18-2-2022-97(L.U.)/2016 T.C. dated 29.06.2022**.

## 3. Certificates & Support

### 4. Certificates

- **Rejection Criteria:** An offer is liable to be rejected if the bidder fails to upload any certificates/documents sought in the Bid document, ATC, or Corrigendum.

### 5. Service & Support

- **Office Location:** An office of the Service Provider **must be located in the state of the Consignor**. Documentary evidence is mandatory.

### 6. Service & Support

- **Communication:** The Bidder/OEM must provide a **Dedicated/Toll-Free Telephone No.** for service support.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
