1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within $L-1+ 15\%$ of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

4. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

5. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The bidder must have registered office in Pune district and provide the documentary proof.
2. The bidder shall provide police verification of himself not older than 3 months from the date of publication of the bid. In case bid is awarded to any bidder, the bidder shall produce latest police verification report of its staff to be deployed at this Institute
3. The bidder shall provide Central Labour license and other statutory clearances (EPF, ESI and GST registration).
4. The wages for personnel deployed shall be paid according to the rates and Variable Dearness Allowance (VDA) revised from time to time by the Central Labour Commissioner for sweeping and cleaning personnel (Housekeeping). The bidders must provide an undertaking that they will pay wages as per the Central Labour Commissioner's rates and provide other facilities such as EPFO, ESI, etc. The working hours of the personnel deployed shall not exceed 8 hours or the limit specified in the Central Labour Commission rules for sweeping and cleaning personnel. If the bidder fails to submit the undertaking while bidding, their bid will be outrightly rejected.
5. The bidder may visit the institute with prior permission to inspect the area before participating in the bid .
6. The bidder shall specify in the bid the number of employees to be deployed per day throughout the year .
7. A minimum of 3 years of service experience in providing housekeeping services is required from the bidder.
8. After being awarded the service contract, the bidder shall submit all documents related to the payment of wages and incidental charges as mentioned in the bidding documents or contract while submitting bills through the GeM Portal. If submission through the GeM Portal is not possible, the service provider shall submit the bill offline, including adjustments for enhanced by the bidder, offline bill shall be provided by the seller for only enhanced VDA difference amount.
9. The liveries for the personnel deployed shall be provided by the service provider at their own cost.
10. Any discrepancies observed during the contract period will result in the cancellation of the contract with one month's prior notice.
11. In the absence of any manpower, prior arrangements for replacements must be made, and the same shall be communicated to RARI, Pune.
12. The bidder shall upload an undertaking stating that they have not quoted a service charge lower than 3.85%. If a service charge lower than 3.85% is quoted, the bidder acknowledges that their bid will be outrightly rejected.

The service provider shall pay the salaries/wages of its contracted staff deployed at the buyer's location on their own by the 7th day of every month and then claim payment from the buyer along with all statutory documents such as PF, ESIC, etc., as well as the bank statement showing payments made to the staff. Bidder shall make payment irrespective of clearance of bills from this institute, which is subjective to availability of funds (Maximum possibility of 3 months to be waited to clear the payments).

14. In the event of any untoward incident due to negligence of the manpower provided by the service provider, resulting in damage to property or pilferage, the cost shall be borne by the service provider.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Preference sections of the bid, unless otherwise allowed by GeM GTC.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
