1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 3. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Generic

9. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.

10. **Generic**

11. **Scope of Supply**

12. **Turnover**

14. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. 17. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

18. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

19. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

20. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 10 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

21. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. **Acceptance and Payment.** Items shall be accepted and CRAC shall be generated only after satisfactory completion of inspection/trials (as per scope of supply) at the user location. Payment shall be made to the firm within 40 days from the date of CRAC generation, through offline mode

2. **Definition of Delivery.** The term 'delivery' shall imply supply, installation, testing, and commissioning of goods/services, whichever is applicable as per the scope of supply. The successful bidder shall ensure delivery within the stipulated contract delivery period.

3. **Performance Security.** The successful bidder shall furnish Performance Security within 15 days of award of contract on GeM in the form of Insurance Surety Bond/Account Payee Demand Draft/Fixed Deposit Receipt/Bank Guarantee from a commercial bank, along with SFMS-transmitted confirmation. The amount shall be 5% of contract value, valid for 60 days beyond completion of all contractual obligations, including warranty obligations.

4. **Updating Delivery Details.** The seller shall update delivery details on the GeM portal only after successful completion of supply and commissioning as per the scope of supply.

5. **Bid Security & Product Details.** All the Bidders must submit Bid Security Declaration and Make and Model of all the items wherever relevant along with Technical Catalogues/Brochures of the offered products as per the Technical Specification document.

6. **Transporter/Representative Details.** The successful bidder shall communicate the details of their transporter/representative to the Buyer at least one day prior to physical delivery, through e-mail, phone, or any other appropriate means of communication. Details shall include copies of Aadhaar, Driving License, and RC of vehicle for the transporter, and Aadhaar for firm representatives. Originals must be carried during delivery.

7. **OEM Authorization.** All bidders shall submit a valid OEM Authorization Certificate for the offered product, issued directly by the OEM .

8. Experience and Past Performance.

8.1 The Bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bidder') should have regularly for at least the last three years, ending 31st March 2025 (hereinafter called 'The Relevant Date'), manufactured and supplied (erected/ commissioned) similar equipment (Articulate Booms etc.), with the same or higher specifications (hereinafter called 'The Product'); and

8.2 'The bidder' should have manufactured and supplied (erected/ commissioned) at least 01 Number (hereinafter referred as 'The Qualifying Quantity') of 'The Product' in at least one of the last five years ending on 'The Relevant Date'; and out of which at least 01 Number of offered version/ model of 'The Product' should be in successful operation for at least 01 Year on the date of bid opening.

10. Financial Standing (Under all Conditions).

10.1 The average annual financial turnover of 'The Bidder' during the last three years, ending on 'The Relevant Date', should be at least 29 Lakhs, as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

10.2 The net worth of the Bidder firm (manufacturer or principal of authorized representative) on 'The Relevant Date' should not be less than 18 Lakhs.

10.3 The net worth of the Bidder firm (manufacturer or principal of authorized representative) should not be negative on 'The Relevant Date' and also should have not eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'.

11. **Product Support.** The seller shall provide product support for a minimum of 10 years, inclusive of 1-year warranty, covering stores, assemblies/sub-assemblies, fitment items, consumables, Special Maintenance Tools (SMT)/Special Test Equipment (STE) subcontracted from other agencies/manufacturers.

12. **TECHNICAL LITERATURE / CERTIFICATES / DOCUMENTATION** . The Bidders are required to submit following certificates at the time of delivery:-

13. **Dispatch Clearance.** Delivery of items shall commence only after receipt of formal Dispatch Clearance from the Buyer. Under no circumstances shall the supplier initiate shipment without such clearance.

14. **Compliance to technical specifications.** The bidder shall submit a Statement of Compliance with respect to the Technical Specifications document. Any deviations from the specifications shall be clearly indicated and justified in detail. Such deviations will only be acceptable if they offer better standards or latest technology, or are in accordance with the OEM's standard design, while still meeting the functional requirements of the equipment. The Buyer reserves the right to verify the authenticity and validity of such deviations and may, at its discretion, accept or reject them.

15. CALIBRATION. All the measuring equipment/gauges where fitted, **as well as** operating parameters, **shall be duly calibrated with a** validity till one year **from the date of handing over. Accordingly,** Calibration Certificates **from** NABL-accredited laboratories **shall be submitted along with each equipment, to certify the requisite calibration.**

16. **Scope of Civil Works.** All civil works associated with foundation, erection, installation of equipment, etc., shall be considered as part of the overall scope of work and included in the quoted price under the price bid.

17. **Rectification of Damages.** Any damage caused to existing structures during the execution of work s

shall be made good by the Seller at his own cost. The site shall be left clean and tidy upon completion of work. Rectification and making good shall conform to the standards of workmanship originally used in the work, and the finished work shall match the existing work in all respects to the satisfaction of the Engineer-in-Charge.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to

such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
