3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10

Crone, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

#### Special terms and conditions-Version:1 effective from 27-05-2025 for category E-cart for Goods

##### 1. Special Terms and Conditions for E-cart for Goods

1. This category is created to cater to the requirement of buyer for procurement of E-cart for goods. This category is a **BID-ONLY Category**, and procurement will occur exclusively through the bidding process.
2. The details on the application and specifications for the body/container are to be defined by the buyer in the bid.

##### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the

additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

## 3. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

## 4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

## 5. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

## 6. **Certificates**

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

## 7. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

## 8. **Buyer Added Bid Specific ATC**

6. According to Government of India the product manufacturer should have manufacturing facility which will promote "Make in India" Factory Licence.

7. Bidder and OEM Submit Documents ISO 9001, ISO 14001, ISO 45001

8. All the bidders or OEM are requested to upload all the certificates like warranty

, ESC matrix, toll free number, valid date or during the tender period.

9. The manufacturer should have dedicated service centred to provide quick response against warranty in case of any issue is noticed or raised.
10. The contractors/bidders must be authorized by the OEM to participate in the tender and the certificate must be enclosed with the bidder's documents.
11. OEM Authorization Certificate in proper format should be required for any query or confirmation of information related to the bidder.
12. According to Bid/Estimate Supply and Work be done under supervision of Junior Engineer, Nagar PanchayatAtsu.
13. Junior Engineer, Nagar PanchayatAtsu ensure work or supply completed by bidder according to bid/Estimate and verify the Bill after that the payment will be proceed.
14. Non-blacklisting and non-insolvency affidavit in favour of Executive Officer, Nagar PanchayatAtsu, Auraiya along with stamp paper of Rs. 10/- shall be uploaded and original copy of affidavit shall be submitted by the bidder/OEM to the office within 05 days from the date of bid opening.
15. Audited turnover report of last three years to be uploaded by OEM or Bidder.
16. OEM Make and Brand Registration Certificate to be uploaded.
17. PAN, GST, Work Experience, ITR will be uploaded.
18. EMD should be deposited through NEFT/RTGS in the account of Nagar PanchayatAtsu in Central Bank of India Branch-Atsu, Account No. 3772232114 IFSC Code-CBIN0284885. Bidder has to upload scanned copy of EMD slip along with bid and ensure delivery of hard copy to office within 5 days from bid closing date/ bid opening date.
19. EMD deposit will be returned only after one year of completion of the work and if the work/supply is found satisfactory.
20. Bidder should Maintenance of Supply and work will have to be done for 3 years as per Government Order otherwise action will be taken to blacklist the bidder.
21. No any types of Exemptions are allowed in subject of EMD.
22. No dues Certificates Issued by bank.
23. Bidder must upload Bank Solvency.
24. The Bidder should have to submit a sample before the end date of the bid.
25. The Bidders should have equal or more experience in same Product.
