1. ### 1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 4. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

### 5. **Service & Support**

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

### 6. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

### 7. **Service & Support**

### 8. **Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

#### 9. Buyer Added Bid Specific ATC

1. Bidder must have excellent gem rating.
2. Black list declaration need to enclose on non-judiciary stamp.
3. GEOGRAPHICAL PRESENCE- Uttar Pradesh
4. The Bidder should have submit ISO 9001:2015 (Quality Management System), ISO 14001:2015 (Environment Management System) ISO 45001:2018 (Occupational Health & Safety Management System), ISO 31000:2018 (Risk Management).
5. It is Mandatory for All Bidders to Submit the Detailed Design and Drawing and EMD Before end date of bid at Office for Physical Verification of specification drawing and EMD of the quoted product at Nagar panchayat Dostpur Sultanpur Office.
6. The bidder shall submit satisfactory work completion certificates from State Gov./ULB/Ministries/Departments of Government of India during last three years. In case documents are found to be forged or fake etc. the bid shall be rejected.
7. A copy of GST/PAN number shall be submitted.
8. An undertaking be submitted that the rates quoted for the items are not exceeding the rates quoted by them to other Ministries/Departments
9. It will be mandatory to upload the EMD receipt in the name of Executive Officer, Nagar Panchayat Anpara as security amount of 02% along with the tender.
10. The right to cancel the tender without giving any reason will be vested in the undersigned.
11. In case of any dispute, the tender will be under the jurisdiction of the Sessions Court Sonbhadra .
12. It is mandatory to attach an affidavit of non-proven guilt of the supplier/firm regarding non-involvement in any criminal case and non-blacklisting on a stamp paper of Rs. 100.00 which will be verified by a notary
13. It will be mandatory to attach GST enrollment certificate and self-attested photocopy of PAN card of the firm with the tender
14. All documents must be certified by the firm/supplier with self-attested seal and stamp.
15. It will be mandatory for the supplier/firm to provide the guarantee/warranty given by the company, and it is mandatory for the supplier/firm to be an authorized dealer by the company.
16. The bidder will have to pay all taxes as per rules. The tender of the bidder not quoting tax-free rates will be considered automatically cancelled.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
