### 1. **Generic**

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Turnover**

**Bidder Turn Over Criteria:** The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- Financial Standing:** The bidder must not be under liquidation, court receivership, or similar proceedings, and must not be bankrupt. An undertaking to this effect must be uploaded.
- Product Obsolescence:** Bidders shall quote only products that are not obsolete and have at least 1 year of residual market life (not declared end-of-life by the OEM).

- Service Centers:** Bidder/OEM must have a functional service center in the Consignee's State. If not present, it must be established within 30 days of award. Payment requires evidence of this center.
- Document Compliance:** Offers are liable for rejection if any certificates/documents sought in the Bid, ATC, or Corrigendum are missing.
- Support Contact:** Bidder/OEM must provide a dedicated/toll-free telephone number for service support.

- **Technical Verification:** (Reiteration) Data sheets must be uploaded for verification against specifications to avoid rejection.
- **Escalation Matrix:** Bidder/OEM must provide an escalation matrix of telephone numbers for service support.
- **Experience Criteria:** Bidder/OEM must have supplied similar category products to Govt/PSU/Public Listed companies for 3 years. Relevant contracts must be submitted.
- **Imported Products:** For imported items, the OEM or Authorized Seller must have a registered office in India for after-sales service.

- **Material Testing:** Material test certificates must be sent with the supply. Buyer's lab results are the sole criteria for acceptance.

- **Pre-dispatch Inspection:** Goods will be inspected at the Seller's premises. Buyer bears inspection agency fees; Seller provides facilities for in-house testing. 7-day notice required.
- **Scope of Supply:** The bid price includes all cost components for the "Supply of Goods" only.
- **Warranty Rectification:** Defects must be rectified within 5 days. Delay attracts a penalty of 0.5% of unit price per week (max 10% of contract value).
- **Specific Certificates:** Bidders must upload test certificates, and other prescribed approvals as per product specifications.
- **OEM Warranty:** The warranty certificate must be submitted specifically on the OEM's letterhead.
- **BoQ Compliance:** Bidder must submit a BoQ (Bill of Quantities) compliance of Technical Specifications.
- **Specific Forms:** Bidder must submit all documents including T-6 and an affidavit for Bid Validity of 90 days.
- **Registration Documents:** Copy of PAN Card, Firm Registration Certificate, and GST Registration must be provided.
- **Non-Blacklisting Affidavit:** An affidavit is required stating the firm is not blacklisted by any Govt Department as of the bid date.
- **Payment Terms:** No advance payments will be released; all payments are subject to verification after supply.
- **Right to Reject:** The department reserves the right to reject any or all bids (including L1) without assigning a reason; an affidavit acknowledging this is required.
- **BIS CRS Requirement:** As per Government Act, all fittings must have a CRS Number (Compulsory Registration Scheme) from BIS as per the relevant IS standard.
- **Technical Compliance:** Bidder must submit BoQ (Bill of Quantities) Compliance of Technical Specifications.
- **Organizational Documents:** Submission of Factory License and Certificate of Incorporation is mandatory.
- **Quality & Environmental Certifications:** Bidders must provide ISO 9001, ISO 14001, and ISO 18001 certifications.
- **Bid Validity:** An affidavit confirming a Bid Validity of 90 days must be uploaded.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्यवाई का आधार होगा।/In terms

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
