However, each and every member of the consortium shall be equally responsible for the complete execution of the project contract. An undertaking to this effect is to be uploaded with bid.

Technical Qualification and Minimum Performance Requirements:

The Bidder must have technical experience of construction work of Dismantling of 3-Phase 415 V 50 Hz. 1450 RPM Cooling Fan from radiator of 40 MVA T/F-I & II including opening of connection nut bolts etc. located in Pooranpur, Pilibhit at any Transmission Lines.

The Part-II (Price bid) of only those firms shall be opened who shall fulfill following pre-qualifying requirements. The tenderers are desired to submit the following documents in support of the same in Part-I of the tenders failing which Part-II (Price bid) of the tender shall not be opened. However, mere issue of tender documents shall not entitle the tenderer for opening of Price Bid (Part-II), if he does not fulfill pre-qualifying requirements:

01. The tenderer shall submit copy of last three years Income Tax clearance certificate/Return filed ending 31st March 2025, and PAN Card.

Applicant must submit details in support of above as per Table A-1 along with necessary documents.

2. Applicants Credibility Criteria:

- a. The Applicant who stands currently debarred by UPPTCL / Any DISCOM of UP / Govt. of UP or black listed by any Distribution/ Transmission/ Generation Utility/Govt. Department in India as on the schedule date of opening of tender shall not be eligible to participate in this tender.

3. COMPLETION PERIOD :

Work completion period shall be 15 days from date of Contract or Instructed by S.D.O. ETSDDohna/ Pilibhit or Availability of Shutdown.

4. PENALTY :

Penalty @ $\frac{1}{2}$ % per Week or Part thereof Subject to Maximum 10% shall be deducted for Incomplete Portion of Work, if not completed within Stipulated Time and the Firm was Found Responsible for Delay.

1. All men and T&P arranged by the contractor.
2. GST shall be paid extra.
3. For any hazard and accident, the contractor is itself responsible.
4. Required Shutdown will be provided.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
