If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 10. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 11. Inspection of Stores by Nominated Inspection Authority / Agency of buyer or their authorized representatives

An independent third party Professional Inspection Body can help buyer in mitigating buyer's risk with pre-dispatch/post-dispatch inspection in order to ensure that equipment, components, solutions and documentation conform to contractual requirements. The buyer has a right to inspect goods in reasonable manner and within reasonable time at any reasonable place as indicated in contract. The decision of the purchaser representative /inspection authority regarding acceptance / rejection of consignment shall be final and binding on the seller.

The Seller shall provide, without any extra charge, all materials, tools, labour and assistance of every kind which the Inspecting officer may demand of him for any test, and examination, other than special or independent test, which he shall require to be made on the seller's premises and the seller shall bear and pay all costs attendant thereon.

The seller shall also provide and deliver store / sample from consignment under inspection free of charge at any such place other than his premises as the Inspecting officer may specify for acceptance tests for which seller/OEM does not have the facilities or for special/ independent tests.

In the event of rejection of stores or any part thereof by the Inspecting officer basis testing outside owing to lack of test facility at sellers premises, the seller shall, on demand, pay to the buyer the costs incurred in the

inspection and/or test. Cost of test shall be assessed at the rate charged by the Laboratory to private persons for similar work.

Inspector shall have the right to put all the stores or materials forming part of the same or any part thereof to such tests as he may like fit and proper as per QAP/governing specification. The seller shall not be entitled to object on any ground whatsoever to the method of testing adopted by the Inspecting officer.

Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

The seller shall if so required at his own expense shall mark or permit the Inspecting officer to mark all the approved stores with a recognised Government or purchaser's mark.

22. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

22.1. **Liquidated Damages.** In the event of the Seller's failure to submit the Bonds, Guarantees and documents, supply the stores/goods and conduct trials, installation of equipment, training, etc as specified in this contract, the Buyer may at his discretion, withhold any payment until the completion of the contract. The Buyer may also deduct from the seller as agreed, liquidated Damages to the sum of 0.5% of the contract price of the delayed / undelivered stores / services mentioned above for every week of delay of part of a week, subject to the maximum value of the liquidated damages being not higher than 10% of the value of delayed stores.

22.2. **Franking clause.** The following franking clause will form part of the contract placed on a successful bidder:-

22.2.1 **Franking Clause in the case of Acceptance of Goods.** "The fact that the goods have been inspected after the delivery period and passed by the inspecting officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the buyer under the terms and conditions of the contract".

22.2.2 **Franking Clause in the case of Rejection of Goods .** "The fact that the goods have been inspected after the delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the rights of the Buyer under the terms and conditions of the contract."

22.3. Risk and Expense clause

22.3.1. Should the stores or any installment thereof not be delivered within the time or time specified in the contract documents, or if defective delivery is made in respect of the stores or any installment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.

22.3.2. Should the stores or any installment thereof not perform in accordance with the specifications/parameters provided by the SELLER during the check proof tests to be done in the BUYER's country, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.

22.3.3. In case of a material breach that was not remedied within 45 days, the buyer shall, having given the right of first refusal to the seller be at liberty to purchase, manufacture from any other source as he thinks fit, other stores of the same similar description to make good- such default.

22.3.4. In the event of the contract being wholly determined the balance of the stores remaining to be delivered there under.

22.3.5. Any excess of the purchase price, cost of manufacturer, or value of any stores procured from any other supplier as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the seller. Such recoveries shall not exceed 05% of the contract.

22.4. **Force Majeure Clause.**

22.4.1. Neither party shall bear responsibility for the complete or partial non performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the procurements of the present contract). If the non performance result from such force majeure circumstances as flood, fire, earth quake, pandemic and other acts of God as well as war, military operation, blockade, acts or actions of state authorities or any other circumstances beyond the parties control, that have arisen after the conclusion of the present contract.

22.4.2. In such circumstances the time stipulated for the performance of an obligation under the present contract is extended correspondingly for the time of action of these circumstances and their consequences.

22.4.3. The party for which it becomes impossible to meet obligations under this contract due to force majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 days from the moment of their beginning.

22.5. **Fall Clause.**

22.5.1. The price charged for the stores supplied under the contract by the seller shall in no event exceed the lowest prices at which the seller sells the stores or offers to sell stores of identical description to any persons/organisation including the purchaser or any department of the Central Government as the case may be during the period or till the performance of all supply orders placed during the currency of the rate contract is completed.

22.5.2. If at any time, during the said period the seller reduces the sale price, sells or offers to sell such stores to any person/organization including the Buyer or any deptt, of central govt or any department or the state govt or any statutory undertaking of the central or state government as the case may be at a price lower than the price chargeable under the contract, he shall forthwith notify such reduction or sale or offer of sale to the purchase/contracting auth and the price payable under the contract for the stores of such reduction of sale or offer of the sale shall stand correspondingly reduced. The above stipulation will, however, not apply to :-

22.5.2.1. Exports by the seller.

22.5.2.2. Sale of goods as original equipment at price lower than charged for normal replacement.

22.5.2.3. Sale of goods such as drugs which have expiry dates.

22.5.2.4. Sale of goods at lower price on or after the date of completion of sale/ placement of the order of goods by the authority concerned under the existing or previous rate contracts as also under any previous contract entered into with the central or state govt. depts, including their undertakings excluding joint sector companies and / or private parties and bodies.

22.5.2.5. The seller shall furnish the following certificates to the paying authority alongwith each bill for payment for supplies made against the rate contract @ We certify that there has been no reduction in sale price of the stores of description identical to the stores supplied to the government under the contract herein and such stores have not been offered/sold by me/us to any person/organization including the purchaser or any department of central government or any statutory undertaking of the central or state government. As the case may be up to the date of bill/the date of completion of supplies against supply order placed during the currency of

the rate contract at price lower than the price charged to the government under the contract except for quantity or stores categories under sub-clause (a), (b) and (c) of Sub-Para (ii) above details of which are given below.

22.6. **Termination of Contract.** The buyer shall have the right to terminate this contract in part or in full in any of the following cases:-

22.6.1. The delivery of the material is delayed for causes not attributable to force majeure for more than 15 days after the scheduled date of delivery.

22.6.2 The Seller is declared bankrupt or becomes insolvent.

22.6.3 The delivery of material is delayed due to causes of force majeure by more than 45 days provided force majeure clause is included in contract.

22.6.4 The buyer has noticed that the seller has utilised the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.

22.7. **Repeat Order Clause (7.13.4 of DPM 2009).** Wherever considered necessary, provision may be made in the RFP and the contract for Repeat Order. A Repeat Order against a previous order may be placed at the same cost and terms and conditions as per the original order/contract with the approval by the CF and concurrence of integrated finance, wherever required as per the delegation of financial powers.

22.8. **Transfer and Sub letting.** The seller has no right to give, bargain, sell, assign or sublet or otherwise dispose of the contract of any part thereof, as well as to give or to let a third party take benefit or advantage of the present contract or any part thereof.

22.9. Bidder can submit (EMD 3%).

22.10. No Chinese components will be used and certification to this effect will be provided by the Vendor.

22.11. Brochure/ Technical Manual of the item should be provided by the OEM/ Authorised vendor.

22.12. In case of OEM/ Authorised vendor, copy of agreement valid up to and covering the warranty period must be provided.

22.13. **Warranty.** Warranty minimum 03 years OEM warranty (certificate is required).

22.14. Vendors to comply with Rule 150 (iv) of GFR-2017. 19.17. OEM and bidders should provide declaration that they are not blacklisted by any Government Organization or Agency.

22.15. List of any spare parts to be mentioned clearly.

22.16. No Chinese Components Certificate.

22.17. Local Content Certificate.

22.18. If considered necessary, Technical Evaluation Committee may invite those vendors who meet essential parameters for technical presentation/ clarification in the Pre-Bid.

22.19. **Shelf Life.** Shelf Life up to 07 years.

22.20. The Technical Evaluation Committee will invite only those vendors who meet essential parameters for technical presentation and clarification with respect to qualitative requirements at Champawat for doing physical and field evaluation for ascertaining compliance of qualitative requirement of the product being offered.

22.21. **Technical Presentation.** Technical presentation will be carried out by all bidders/ Sellers on the date, time and location specified by the Buyer/ Technical Evaluation Committee (TEC). During the Technical Presentation the Seller/ Bidder is expected to physically produce two samples for technical specification evaluation by the TEC, in the User Units. Queries of Vendors will be answered by the TEC, during the Technical Presentation or later, on as required basis.

22.22. DPIIT/DIPP Registration certificate / license and unlimited liability certificate is required from seller.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or

bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
