1. The battery supply condition (factory charged), material and construction, separators, terminal post, cell lids, plates, electrolyte, connector, designation of cells, charger, flame arrestor, and marking requirements shall conform to the IS 15549 standard.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
