1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

- The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Additional Terms and Conditions of Contract

1. Work Experience: -

As per Service GCC 2018, Para 2.6.1, the bidder must have satisfactorily completed (including ongoing contracts with at least 35% of the advertised bid value billed) one similar single service contract in the last three financial years and the current financial year up to the tender opening date. This clause replaces the standard criteria of 80%-50%-40% completion model.

2. Financial Standing:

(a) **T1 - Financial Turnover:** The bidder should have an aggregate turnover of not less than 1.5 times the advertised bid value over the last three financial years and current year (up to tender opening). Turnover must be certified by a Chartered Accountant with seal, signature, UDIN, FRN and Membership number. If UDIN and FRN number not mentioned on Turn over certificate otherwise offer will be disqualified during the technical evaluation.

(b) **T2 - Liquidity:** The bidder must demonstrate access to liquid assets, credit lines, etc., worth 5% of the estimated bid value, net of existing commitments. Certification must be provided by a Bank Manager.

3. Vehicle Requirements:-

a) Vehicle should be in good condition, not older than 3 years as of tender opening date.

b) Vehicle must be registered as a commercial vehicle, meet all requirements under the Motor Vehicle Act, and have valid insurance, pollution control, tax clearance, and road permits for NWR.

c) The vehicle must either be registered in the name of the bidder. two similar or higher-category vehicles. The RC of vehicle must be attached with the original bid otherwise offer will be disqualified during the technical evaluation.

d) If a vehicle is changed during the contract period, full supporting documents and a judicial stamp agreement must be submitted for the new vehicle.

4. Driver Requirements:

a) Drivers must have a valid commercial driving license and at least 5 years of experience.

b) They must exhibit good behavior, wear neat attire (preferably uniform), and carry a mobile phone with active internet access and Google Maps for navigation.

c) The driver must be reachable at all times during duty.

5. Operational Conditions:-

a) Vehicles should be available 24 x 7, including emergencies.

b) A log book must be maintained to record daily KMs/hours for monthly billing and audit.

c) Only genuine use cases should justify vehicle usage.

d) Additional KM charges will be paid only if usage exceeds the prescribed limit over a three-month average.

e) For the purpose of extra payment on account of extra KM running of the vehicle, total KMs run by the vehicle for 3 months duration shall be considered. In case a vehicle is run for shorter KM in one month and more KM in the next month, total KM will be clubbed. Such clubbing shall be done for 3 months period starting from the next month of the date of L.O.A. For example if a vehicle is hired for stipulated 2500 KM per month, then additional payment for extra KM will be paid when total KM running of the vehicle is more than 2500x3-7500 KM over a period of 3 months. Counting of such 3 months period will be starting from the next month of date of L.O.A.

f) If contractor fails to provide multi utility vehicles then SUV vehicles may be permitted with recovery of 5000 per month per vehicle.

6. Document Submission:

The following must be submitted with the original bid, otherwise the bid will be disqualified during technical evaluation:

a) Copy of GST registration

b) Copy of ESI & EPFO registration.

c) Udyam Registration certificate.

d) RC of vehicle.

8. Office Location:-

The registered office of the service provider must be located in the district of the consignee. Documentary evidence must be submitted.

9. Service Performance and Termination:

- a) The contract may be terminated by Railway with 1-month notice, or earlier in case of unsatisfactory service.
- b) If the contractor wants to terminate, 3 months' advance written notice is required.
- c) Unsatisfactory service includes failure to meet contractual obligations.
- d) The hiring contract can be short-closed at Railway's discretion.
- e) The performance guarantee will be governed by GCC for Services.

10. Billing and Payment:-

- a) Invoices must be raised in the name of the Buyer with their GSTIN.
- b) While generating invoices on GeM portal, the scanned GST invoice and screenshot from GST portal showing GST payment must be uploaded.

11. Monthly bills will be processed only after certification from the user officer confirming vehicle availability and satisfactory performance.

12. **Penalty for Defaults:** Penalties for issues like late reporting, non-reporting, poor condition of vehicle, etc., will be as per GeM SLA.

13. GeM and Railway Rules:-

- a) All terms and conditions will be governed by the latest General Conditions of Contract for Services of Indian Railways and GeM SLA.

14. The quantity and duration of hired vehicles may be increased or decreased by 25% and 50% as per GCC and GeM SLA.

15. Disqualifications:

- a) Firms debarred/suspended in the last two years by North western Railway will be disqualified.
- b) No new documents (except clarifications) will be accepted after the opening of the technical bid.
- c) **Non submission of required documents in mentioned in ATC , offer will be disqualified during the technical evaluation.**

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.
