Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

1) Past work experience:

Bidders should have successfully executed work of tubular pipe scaffolding erected for mechanical maintenance job in any fertilizers/ chemicals/ petrochemical industries/ refineries / power plant/heavy water plant or any PSU. Against the claim, the above work order copies should be issued and executed during the last 7 years ending last day of month previous to the month in which application are invited/issued & should be either of following:

One similar completed/executed works costing not less than the amount equal to Rs. 12.00 Lakhs (Excluding GST).

OR

Two similar completed/executed works each costing not less than the amount equal to Rs. 7.50 Lakhs (Excluding GST).

OR

Three similar completed/executed works each costing not less than the amount equal to Rs. 6.00 Lakhs (Excluding GST).

Proof of execution of submitted work order, submit any of the following -

- (i) Completion Certificate/ Customer Acceptance Certificate OR
- (ii) GeM CRAC (Consignee Receipt and Acceptance Certificate) document OR
- (iii) (a) Tax Invoice to the extent of the required Pre-Qualification value and
(b) Proof of receipt of payment like bank statement for the above referred tax invoice OR
- (iv) Any other document indicating work completion/executed for the submitted work order.

2) Average annual financial turnover during the **last three years**, ending 31st March of the previous financial year (i.e. FY 2022-23, 2023-24, 2024-25) should be **at least Rs. 4.50 Lakhs**.

*In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be **at least Rs. 4.50 Lakhs**.*

Bidders shall submit CA certificate / CA audited Profit & Loss accounts, Balance sheets etc. indicating the annual turnover figures, in support of the same. The financial documents has to be CA audited/issued with membership number, seal, signed and with UDIN.

The net worth should not be negative in the balance sheet of last financial year (i.e. net worth should not be negative on 'The Relevant Date').

AND

The Net worth of Bidder should have not eroded by more than 30% in the last three years, ending on 'The Relevant Date'. It means the net worth of last financial year should not be less than 70% compared to the 3rd last financial year.

In case, the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable -

- Ø The net worth in each of these years should not be negative
- Ø Net worth in respect of the immediate previous financial year should not have eroded more than 30 percent than that of its previously audited financial statement. 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
