1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

TERMS AND CONDITIONS

1. The payment to the outsourced staff shall be made by the agency by the 7th of every month without any failure. In case of non-payment without any justified reason, a penalty of Rs. 100/- per day per worker shall be recovered from the agency bill.
2. The payment shall be made preferably through NEFT. In case, the payment is made by Cheque or DD that should be done in the presence of the SDE / AE / JE concerned.
3. There should be no extortion of money from the outsource staff in lieu of above payment of wages or otherwise.
4. Payment should be made as per the prevalent DC rates. The difference in the DC rates at the time of allotment and at the time of payment shall be made extra to the agency after the payment.
5. If due to any administrative reason, the bill submitted by the agency for the preceding month is not cleared, the agency should continue to make the payment to the outsourced staff for at least 3 months without failure.
6. The agency shall first make the payment of EPF / ESI / GST or any other statutory dues and then the same shall be reimbursed to the agency on production of original documentary proof. The original copies shall be deposited with the department, however the agency can obtain the attested copies from the department. The separate ECR Challan (Contract Wise) should be filled and supplied.
7. The agency shall submit the bill to the department on monthly basis after making the payment to the outsource staff and depositing the statutory payments as mentioned above complete with documentary proof of payments and bank statement of workers to the complete satisfaction of SDE/AE/JE.
8. The outsource staff deputed by the agency shall report to the concerned SDE/AE/JE who shall maintain list of such staff.
9. The T&P required for safety of the staff shall be supplied by the agency.
10. The department is free to change the shifts of the outsourced staff and in case of any requirement the place of duty can also be shifted by the concerned SDE/AE/JE.
11. The agency shall change the outsource staff, in case of any incident is raised

by the concerned SDE/AE/JE. The agency cannot change any staff on his own without the consent of the concerned SDE/AE/JE.

12. In case any of the outsourced staff remain absent, the agency shall provide substitute for the same so that the work may not suffer.
13. In case there is any loss to the department due to negligence of the outsource staff, it is the duty of the agency to borne the same.
14. The agency / contractor should be registered with GST Department.
15. The Performance Guarantee should also be of any Nationalized Bank of Tri-city.
16. The agency will be fully responsible for adhering the labour laws and the safety and security of the outsource staff.
17. The agency should have satisfactorily completed the works as mentioned below during the last 7 years ending last day of the month previous to the submission of tender. Joint ventures are not accepted.
 - a) Three similar works each costing not less than 40% of the tender amount.
 - b) Two similar works each costing not less than 60% of the tender amount.
 - c) One similar work costing not less than 80% of the tender amount.

Note: the value of the executed works shall be brought to the current costing level by enhancing the actual value of the work at simple rate 7% per annum, calculated from the date of completion to the previous day of last date of receipt of tender.

18. Average annual financial turnover on Public Health Works should be at least 30% of the estimated cost put to tender during the immediate last three consecutive financial years ending 31st March 2025. The value of annual turnover figures shall be brought to current value by enhancing the actual turnover figures at simple rate of 7% per annum. Year in which no turnover is shown would also be considered for working out the average. Scanned copy of the certificate from C A with Unique Document Identification Number (UDIN) is to be uploaded. The bidder should not have incurred any loss (Profit after tax should be positive) in more than 2 years during available the last five consecutive financial year. Balance Sheets of financial year 2020-21, 2021-22, 2022-23, 2023-24 & 2024-25 duly certified and audited by the Chartered Accountant should be uploaded. The balance sheet in case of Private / Public Limited Company means its standalone fin

ancial statement and consolidated financial statement both.

19. Bidders are required to submit TDS certificate in Form 16-A, in case of similar works are executed for a private body, which shall form basis for establishing the completion cost of similar works executed by the bidder.
20. The bidder should furnish the **AFFEDAVIT** as per Annexure, duly attested by Notary Public. The affidavit of date prior to three months from the date of publishing of tender shall not be considered for qualification of Technical Bid.
21. **SERVICE AND SUPPORT:** The tender will be accepted only of those firms who have their office in the Tri-city i.e. Chandigarh, Panchkula and Mohali. The documentary evidence in this regard should be submitted. Also there should be a dedicated Telephone number for Service Support.
22. **GENERIC:** The bidder should not be under any liquidation, court receivership, Bankrupt or similar proceedings. Bidder should upload undertaking in this regard with bid.
23. **CERTIFICATES:** The bidder offer is liable to be rejected without giving any notice, if the required documents including certificates and Affidavit sought in the bid document or corrigendum is not uploaded.
24. As per the circular no. 1188 dated 06.05.2024 issued by the Labour Commissioner, Chandigarh the agency shall obtain license from the Labour Department, U T, Chandigarh within a period of 30 days of the commencement of work.
25. The agency has to produce the original documents as and when asked by the department, the failure of the same will entail summarily rejection of its tender.
26. The department reserves the right to verify the particulars furnished by the applicant independently. If any information furnished by the applicant is found incorrect at a later stage, the firm / contractor shall be liable to be debarred for future tendering in Engineering Department.
27. Corrigendum / Amendment to the tender if any will be uploaded on the website. This must be noted by the Agencies / Bidders.
28. The department reserves the right to reject any or all the applicants / tenderers without assigning any reason.
29. **FORMS OF EMD AND PBG :** Successful bidder shall submit Performance Security @ 5% of the tendered amount in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GEM GTC). DD should be made in favor of Executive Engineer, Project Public Health Division No.3, Sector 9 payable at Chandigarh. After award of contract, successful bidder can upload scanned c

copy of the DD in place of PBG and has to ensure delivery of hard copy of the original DD to the Buyer within 15 days of the award of contract.

30. GST/Taxes as applicable to the Chandigarh Administration will be deducted from the bill.
31. Ministry of Finance letter No. 29 (1) 2014 Deptt. Of Expenditure PP Division North Block New Delhi dated 28.01.2014 will be part of the agreement.
32. As per letter No.19/C2/2021/PEO(GeM)/885 dated 25.10.2021, the following additional terms and conditions are listed as under:

I. Deployment of existing working / deployed resources (Manpower):-

Number of existing working / deployed resources of the procurement department having job satisfactory certificate, will be continued by the successful service provider under the new contract also subject to their consent to the terms and conditions of new contract concluded on the basis of this bid.

II.
