2. 4. 6. In case of bunch bids, the category of primary product having highest value should meet this criterion.

8. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 9. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

11. Inspection of Stores by Nominated Inspection Authority / Agency of buyer or their authorized representatives

An independent third party Professional Inspection Body can help buyer in mitigating buyer's risk with pre-dispatch/post-dispatch inspection in order to ensure that equipment, components, solutions and documentation conform to contractual requirements. The buyer has a right to inspect goods in reasonable manner and within reasonable time at any reasonable place as indicated in contract. Inspection Fee/ Charges (as pre-greed between buyer and Inspection Agency) would be borne by the buyer as per their internal arrangement but may be recovered from the seller if the consignment failed to conform to contractual specification and got rejected by the Inspection Officer .If so requested and accepted by the seller , initially seller may pay for inspection charges as applicable and get the same reimbursed from buyer if consignment accepted by the Inspecting Officer . For reimbursement seller has to submit proof of payment to Inspection Agency.

Seller/OEM shall send a notice in writing / e-mail to the Inspecting officer / inspection agency specifying the place of inspection as per contract and the Inspecting officer shall on receipt of such notice notify to the seller the date and time when the stores would be inspected. The seller shall, at his own expenses, afford to the Inspecting officer, all reasonable facilities as may be necessary for satisfying himself that the stores are being and or have been manufactured in accordance with the technical particulars governing the supply. The decision of the purchaser representative /inspection authority regarding acceptance / rejection of consignment shall be final and binding on the seller.

The Seller shall provide, without any extra charge, all materials, tools, labour and assistance of every kind which the Inspecting officer may demand of him for any test, and examination, other than special or independent test, which he shall require to be made on the seller's premises and the seller shall bear and pay all costs attendant thereon.

The seller shall also provide and deliver store / sample from consignment under inspection free of charge at any such place other than his premises as the Inspecting officer may specify for acceptance tests for which seller/OEM does not have the facilities or for special/ independent tests.

In the event of rejection of stores or any part thereof by the Inspecting officer basis testing outside owing to lack of test facility at sellers premises, the seller shall, on demand, pay to the buyer the costs incurred in the inspection and/or test. Cost of test shall be assessed at the rate charged by the Laboratory to private persons for similar work.

Inspector shall have the right to put all the stores or materials forming part of the same or any part thereof to such tests as he may like fit and proper as per QAP/governing specification. The seller shall not be entitled to object on any ground whatsoever to the method of testing adopted by the Inspecting officer.

Unless otherwise provided for in the contract, the quantity of the stores or materials expended in test will be borne by seller.

Inspecting officer is the Final Authority to Certify Performance / accept the consignment. The Inspecting officer's decision as regards the rejection shall be final and binding on the seller.

The seller shall if so required at his own expense shall mark or permit the Inspecting officer to mark all the approved stores with a recognised Government or purchaser's mark.

12. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

17. **Generic**

The seller is required to print logo as per buyer's requirement.

18. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

37.10 Following are payment and supply terms:-

37.10.1 Part Payment :- 03, where each part payment corresponds to each schedule (on 70% -3 0% basis)

37.10.2 Part supply:- firm to mention in their quote how many part supply is required by firm. 0 1 lot refers to No. of stores delivered on a single working day.

37.11 For Bid Security / EMD submission / Performance Bank Guarantee:

37.12 The contract concluded firm will be required to furnish a Performance Bank Guarantee through a public sector bank or a private sector bank authorised to conduct government business (ICICI Bank Ltd., Axis Bank Ltd., State Bank of India or HDFC Bank Ltd) for a sum equal to 05% of the supply order value within 30 days for date of supply order. Performance Bank Guarantee will be valid upto 60 days beyond the date of warranty. The specimen of PBG is given in Form DPM-09 (Form15) (Available on MoD Website).

37.12 In the event of the Seller failure to submit the Bonds, Guarantees and Documents, supply the stores/goods and conduct trials, installation of equipment, training, etc as specified in this contract, the Buyer may at his discretion, withhold any payment until the completion of the contract. The BUYER may also deduct from the SELLER as agreed, liquidated damages to the sum of 0.5% of the contract price of the delayed /undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the value of delayed stores.

37.13 In the event of placement of purchase order on any of the participating firms, if items are being dispatched through any courier service or truck, a separate envelope enclosed with invoice, delivery challan, GeM PO and inspection notes if applicable are to be sent along with item and handed over at entry gate.

37.14 The bidder must have solvency certificate from the bank minimum five crore.

37.15 The seller will not resort to usage of any components from 'countries sharing border with India' which can question the security of this unit.

37.16 Force Majeure: Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the contract), if the non-performance results from such Force Majeure circumstances as Flood, Fire, Earthquake and other acts of God, as well as War, Military operations, blockade, Acts or Actions of State Authorities or any other circumstances beyond the control of the parties that might arise after the conclusion of the contract.

37.17 Termination of Contract: The Buyer, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Supplier, may terminate the contract in whole or in part:

37.18 If the Supplier fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Buyer.

37.19 If the Supplier fails to perform any other obligation(s) under the contract.

37.20 If the Supplier becomes bankrupt or otherwise insolvent.

37.21 If the Supplier, in the judgment of the Buyer, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause:

“corrupt practice” means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

“Fraudulent practice” means misrepresentation of facts in order to influence the procurement process or the execution of a contract to the detriment of the Buyer, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Buyer of the benefits of free and open competition.

37.22 Arbitration: As mentioned in paragraph 7.11.1 of DPM-2009 (as amended from time to time), parties to a contract may opt for arbitration if any dispute arising between them does not get resolved through mutual discussion. The standard format of the Arbitration clause to be included in the RFP and the contract is given in Form DPM-8. It may be noted that there is a slight difference in the formats to be used for indigenous and foreign contracts.

37.23 Franking clause – The following Franking clause will form part of the contract placed on successful Bidder –

37.23.1 Franking Clause in the case of Acceptance of Goods “The fact that the goods have been inspected after the delivery period and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the Buyer under the terms and conditions of the contract”.

37.23.2 Franking Clause in the case of Rejection of Goods “The fact that the goods have been inspected after the delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the rights of the Buyer under the terms and conditions of the contract.”

37.24 Transfer and Sub-letting: The Seller has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.

37.25 Warranty –

37.25.1 Warranty period 24 months from the date of delivery/shipment of the said goods stores/articles to the buyer uploaded by seller.

37.25.2 If a particular equipment/goods fails frequently and/or, the cumulative down time exceeds 8% of the warranty period, the complete equipment shall be replaced free of cost by the Seller within a stipulated period of 15 days of receipt of the notification from the Buyer. Warranty of the replaced equipment would start from the date of acceptance after Joint Receipt Inspection by the Buyer/date of installation and commissioning.

37.25.3 In case the complete delivery of Engineering Support Package is delayed beyond the period stipulated in this Supply Order, the Seller undertakes that the warranty period for the goods/ stores shall be extended to that extent.

37.25.4 For procurement of oils and lubricants, the following will be applicable –

37.25.5 The Seller warrants that the special oils and lubricants required during the warranty period of the equipment shall be provided by the Seller himself.

37.25.6 The penalty amounting to 20% of the value of the equipment shall be imposed on the Seller in case the Seller refuses or fails to meet the requirement of oils and lubricants during the warranty period of the equipment.

37.25.7 The Seller shall make available the detailed specifications of all oils and lubricants required to be used in the equipment at the line of initial delivery of equipment to facilitate identification and development of indigenous equivalents to be used after the expiry of the warranty period.

37.26 Liquidated Damages: In the event of the Seller’s failure to deliver the goods by the date specified in the contract the Buyer may deduct from the Seller as liquidated damages the sum of 0.5 % of the contract price of the undelivered goods for delay of each week or part of week and the Seller shall submit the documents after deduction of the liquidated damages subject to a maximum of 10% of the contract price of the undelivered goods. But if the delay is on account of any cause, which the Seller promptly notifies to the Buyer and the Buyer admits as a reasonable ground for extending the time for delivery, no liquidated damages will be payable during the additional time thus agreed to by the Buyer.

37.27 Risk & Expense clause –

37.27.1 Should the stores or any instalment thereof not be delivered within the time or times specified in the contract documents, or if defective delivery is made in respect of the stores or any instalment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.

37.27.2 Should the stores or any instalment thereof not perform in accordance with the specifications / parameters provided by the SELLER during the check proof tests to be done in the BUYER’ s country, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.

37.27.3 In case of a material breach that was not remedied within 45 days, the Buyer shall, having given t

he right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other stores of the same or similar description to make good:-

37.27.4 Such default.

37.27.5 In the event of the contract being wholly determined the balance of the stores remaining to be delivered thereunder.

37.27.6 Any excess of the purchase price, cost of manufacturer, or value of any stores procured from any other supplier as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the SELLER.

37.28 To be eligible for award of contract, Bidder / OEM must possess following certificates / Test Reports on the date of bid opening (to be uploaded with bid) : Latest original NABL/ILAC accredited lab test report (not older than one year from the bid end date) and photocopy of the certificate of the lab, ISO and certificates as per bid requirement. The 18 digit ULR number issued by labs/laboratories should be prominently highlighted on the submitted test report. In case, the subject report not found alongwith the bid documents, the firm will be disqualified.

37.29 Technical compliance statement & adherence to ATC be mandatory submitted without any deviation along with supporting documents and certificates.

37.30 The bidder should submit Original Equipment Manufacturer (OEM) Authorization Certificate duly signed stamped by the OEM of all the products / solutions.

37.31 Bid contains Technical specifications in CCOR & detailed product information in Scope of Work which form an integral part of the current bid. Vendor to ensure complete understanding of the same and supplying of the same in totality and ensure full functionality and handover of the site without any delay and gaps.

37.32 The entire scope of Project requirement includes multiple products from various OEM's. Integration is the essence of the contract and successful bidder to ensure complete & comprehensive delivery of the desired solution hence single quote of Bidder who can undertake complete execution and satisfactory handover of the same shall only be considered.

37.33 Bid splitting/Sub letting is not allowed.

37.34 All storage components supplied as part of required project to be suitably tested with NABL /ILAC accredited lab test report and reports to be submitted along with the Stage wise work completions.

37.35 Fire Safety Standards:

37.35.1 Compliance to standards - All the equipment of detection and alarm system shall have proper approvals and shall comply to the requirements of the EN-54 Standard and be approved by the recognized agencies like LPCB / VdS / BSI / FM Approvals, and shall also comply with IS 2189. Certificates / Approval to be submitted along with the bid.

37.35.2 Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and corrigendum if any.

37.35.3 ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

37.35.4 The bidder is required to upload, along with the bid, all relevant certificates such as BIS license type test certificate, approval certificates as prescribed in the Product in the product specification given in the bid documents.

37.35.5 To be eligible for award of contract, Bidder / OEM must possess following certificates / Test Reports on the date of bid opening (to be uploaded with bid): All Product Test Report, Certifications, Necessary License and Approval.

37.35.6 The bidder should submit Original Equipment Manufacturer (OEM) Authorization Certificate duly signed stamped by the OEM of all the products / solutions.

37.35.7 The project being a software intensive item of work, the following must be ensured to be included in the T&C.

37.35.8 The copyright of software so required be handed over to Indian Army with all safety precautions catered to. This is necessary to have complete control over data feeds and its safety and authority to upgr

ade/ develop the software.

37.35.9 Further, the software so developed should have capacity to be integrated with existing system and be integrated over larger scale or area if required.

37.35.10 Malicious Code Certificate must be provided by the vendor.
