## Roles & Responsibility of the agency

1. To provide the requisite number of Manpower/resources having qualification/experience for each category required.
2. To have this Manpower on its pay roll and shall be employees of the agency for all intents and purpose

s.

3. To provide the Manpower's full details like name, residential address, date of birth, academic qualification previous experience etc. along with a photograph of the person to the concerned employer authority.
4. To verify the police records of this Manpower before their deployment at Directorate of Higher Education, Pune ensure that these resources do not have any criminal records.
5. To undertake background qualification & experience check of these resources before their deployment at Directorate of Higher Education, Pune.
6. To ensure that the personnel deployed are medically fit & certificate of their medical fitness to be provided when called for.
7.
  - i) To comply with all the applicable laws, and rules of Government of India, Government of Maharashtra pursuing and forthcoming.
  - ii) To abide list of Central Labour Laws under Ministry of Labour and Employment Ministry pursuing and forthcoming.
  - iii) Medical Insurance for the resource shall be provided to them as per his/her requirement and the premium of the insurance will be deducted from the salary of the resource.
  - iv) The outsourcing agency shall be wholly and exclusively responsible for payment of wages to the persons engaged by it in compliance of the statutory obligation under all related legislations as applicable to it from **time to time including Minimum Wages Act Contract Labour, Provident Fund, ESIC, Gratuity, Bonus, leave & Professional Tax etc. The outsourcing** agency shall be required to provide particulars of documentary proof/papers deposited to the respective statutory bodies/Government departments i.e. Employees State Insurance, Provident Fund and Service Tax of its manpower resources deployed under the agreement while submission of invoice.
8. To pay the monthly salary to the deployed Manpower through NEFT/RTGS Bank Transfer.
9. **To agree and confirm that the manpower deployed under this project shall:**
  - (i) Have responsibilities and duties as per the circulars/GRs issued by the Government of Maharashtra from time to time.
  - (ii) Not be entitled to any perks or other facilities similar to those p

rovided to on-payroll/confirmed employees of the Directorate of Higher Education during or after the agreement period.

- (iii) Not have the right to demand any type of permanent employment with the Directorate of Higher Education, Pune the Government of Maharashtra, or the Government of India.
- (iv) Not claim any benefit, compensation, absorption, or regularization of services with the Directorate of Higher Education.
- (v) Not divulge or disclose any confidential data of the Directorate of Higher Education to any person or entity.
- (vi) Not join any labor union or resort to strikes, demonstrations, or any other agitation of this nature.
- (vii) Neither directly nor indirectly join nor assist any commotion of civil nature.
- (viii) Render their sincere services to the Directorate of Higher Education to the best of their ability, especially during any kind of natural calamity.
- (ix) Not, in any way, act against the interests of the Directorate of Higher Education.
- (x) Maintain polite, cordial, and positive behavior while working at the Directorate of Higher Education location.
- (xi) Work efficiently while handling assigned tasks, ensuring that their actions promote goodwill and enhance the Directorate of Higher Education.
- (xii) Agree to be frisked/checked by security personnel at the entry/exit of the Directorate of Higher Education or at any time during the performance of their duties.

**10.** No part of the contract nor any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the agency directly or indirectly to any person, firm or whosoever.

### **4.3 Deployment process for the Manpower**

**1. The deployment of manpower shall be done as follows:**

- a) The selected bidder shall provide resumes of suitable resources for each post to the concerned Committee of the **Directorate of Higher Education**.
  - b) The Committee of the **Directorate of Higher Education** shall conduct interviews if required and shortlist the resources.
  - c) The details of the shortlisted resources shall be communicated to the concerned Committee of the **Directorate of Higher Education**.
  - d) The Committee of the **Directorate of Higher Education** shall approve the deployment of the resources.
- 2. The agency shall deploy the manpower within **7 days** from the date of signing the agreement. Any additional deployment requested by the **Directorate of Higher Education** shall be met within **15 days** from the date of the request.
  - 3. The agency shall preferably provide human resources who have prior experience working with the **Directorate of Higher Education** or a similar organization.
  - 4. The agency shall withdraw, replace, or reshuffle such employees if requested by the **Directorate of Higher Education**.
  - 5. The **Directorate of Higher Education** shall pay the agreed man-month r

ate for the deployed resources to the agency as per the payment terms stipulated in this RFP. Failure to comply may result in the bidder having the right to withdraw the resources.

6. No wage/remuneration shall be paid to any manpower resource for days of absence from duty.
7. The directorate of higher Education (DHE) reserves the right to increase or decrease the number of employees based on its operational requirements.
8. The DHE has the authority to increase or decreased the salary & the commission value will be on pro-rata basis
9. In the event that a scheme from the Ministry of Education (MoE) is discontinued, services will be terminated effective from the date of closure without any compensation to the bidder.
10. The DHE has the authority to add new post and salary of new post. Also has the authority to remove existing post, the commission will be on pro-rata basis.
11. The agency shall determine the salary structure and DHE will be responsible for paying the PF Employer's contribution to the agency.
12. The DHE has authority to change qualification criteria for existing post. Also has authority to select qualification criteria for new post.
13. The manpower shall be engaged on a contractual basis for a period of eleven (11) months. Upon completion of each eleven (11) months term, the existing contractual engagement shall come to an end, and a fresh selection process for engagement of candidates shall be undertaken. The continuation of services shall be subject to completion of the prescribed selection process after every eleven (11) months, as per applicable rules and guidelines.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake

compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
