3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. The scope of work for all four events has been tentatively defined; payment will be made based on the amount of work actually completed as per instruction of the buyer.

5. It is the sole responsibility of the tenderer to obtain all mandatory permission from the authorities concerned prior to flying a drone for photography and videography.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-
