If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.

2. a) All the Deliverables will be accepted based on the manufacturer's CoC, Test Results and Nonnuclear Munitions safety Board certification/similar certificate from any India, Explosive test laboratories. based on the performance of the delivered units at BDL stores as per the AT plan at Annexure-2.

b) Acceptance criteria: All the deliverables will be accepted based on the Quality Acceptance Test Plan of Safety Ohmmeter.

3. All the deliverables will be verified for the Part /Drg Number, Specifications (wherever applicable) with the part/Drg number given in Purchase order.

4. Delivery schedule: within 10 weeks from the date of receipt of Purchase order for all items.

5. Warranty: Minimum one year from the date of acceptance of material at BDL, Kanchanbagh Hyderabad against manufacture defects only.

6. The supplier shall ensure to reach the items with the required quality to BDL through adequate packing without any damage.

7. The components shall be delivered to BDL stores (F.O.R BDL, Kanchanbagh, Telangana state-500058) at free of cost.

8. Supplier shall maintain the BDL Product & Production records upto 3 years.

9. Suitable Measuring Instruments and Gauges shall be available with the manufacturer for all basic inspection (Wherever applicable). Wherever facility for inspection is not available with the vendor, the inspection shall be done by the vendor at any of ISO/NABL certified Laboratory.

10. (a) Suitable Measuring Instruments and Gauges shall be available with the manufacturer for all basic inspection (Wherever applicable). (b) Valid Calibration certificates also to be supplied along with the test reports for the equipment's, Gauges etc. used for the inspection of the items. (c) Wherever facility for inspection is not available with the vendor, the inspection shall be done by the vendor at any of ISO/NABL certified Laboratory. Certificates for the same should also be supplied along with the delivery.

11. BDL, its customer and regulatory authorities shall have right to access to the applicable areas of all your facilities, at any level of supply chain involved and all applicable records.

12. Supplier shall be aware of Product conformity requirements, product safety and importance of Ethical behavior.

13. Supplier shall notify to BDL in case of suspected/detected counterfeit parts (if any) during any stage of import/supply.
14. Replacement of the rejected components to be provided on priority basis at free of cost to BDL KBU, Stores.
15. (a) Vendor should provide OEM authorization letter along with technical bid. (b) Vendor should provide User Manual for the item. (c) Quoted items OEM should have service center in India. (d) Vendor should provide demo after delivery at BDL, KBU within a week after delivery. (e) Vendor should provide OEM/ Authorized distributor certificate for the item.
16. Inspection agency: BDL and/or its nominated agency.
17. Payment terms: (a) 90% basic value + 100% taxes will be paid within 30 days after receipt and acceptance of items at BDL. (b) Balance 10% will be paid against submission of Performance Bank Guarantee (PBG) for 5 % PO value valid till warranty period plus 3 months claim period. (c) In case of non-submission of PBG, 10 % payment will be released after satisfactory completion of warranty period only.
18. Vendor shall not have any claim in the design due to any changes during development and production. (a) The supplier shall ensure to reach the items with the required quality to BDL through adequate packaging without any damage. Identification/Traceability numbers should be marked on each Item (b) Replacement for the rejected components shall be provided on Priority basis at free of cost. (c) The components should be free from Defects & Damages.
19. The components shall be delivered to BDL stores (F.O.R BDL, Kanchanbagh, Hyderabad , Telangana State-500058) at free of cost.
20. Option clause: BDL retains the right to place orders for additional quantity up to 100% of original ordered quantity at the same terms and conditions (at the same rate).
21. Security deposit: Security deposit shall be submitted by the successful bidders for 5% of the order value (by way of Online payment / Demand Draft / Bankers Cheque / bank guarantee from scheduled banks) within one week from the date of purchase order and valid up to successful execution of the order till the last delivery date as per purchase order plus 3 months claim period. SD will be released after successful completion of the order and against submission of performance bank guarantee as applicable.
22. Supplier shall not supply non-conforming product/Items against specification.
23. Supplier shall retain the product related records (Processes, Quality Records etc.) up to 3 years.
24. Supplier shall ensure that the persons carrying out the manufacturing of items under this purchase order be aware of Product conformity requirements, Product safety and Importance of ethical behavior etc.
25. The Successful bidder will be debarred / blacklisted for the future tenders for a period as decided by BDL, if the bidder deviates from the agreed terms & conditions after the award of Purchase Order / Work Order / Service Order apart from forfeiture of your EMD.
26. Benefit of ITC Clause: (a) Benefit of Input Tax Credit should be passed on to BDL without fail. (b) Benefit of reduction in rate of GST applicable for the supply, compared to the rate of GST as per the Contract, should be passed on to BDL without fail. (c) A Certificate duly signed by the Company Secretary/ Director/ CFO/ Managing partner/ Proprietor, as the case may be, should be furnished along with the quotation in the following format. "Certified that the benefit of input tax credit and /or rate reduction has been duly and commensurately passed on in terms of section 171 of the CGST Act."

28. Non-Disclosure Agreement (NDA): Party shall submit the NDA duly signed with Seal (in the BDL format) along with Quotation.

29.LD Clause: "Time is the essence of the P.O and delivery should be strictly insisted upon according to the delivery schedule given in the SOs/POs. In the event the supplier fails to deliver the goods / service, within the stipulated delivery period, BDL reserves the right to recover from the supplier, LD and not by way of penalty an amount as detailed in terms and conditions. A sum of 0.5% of the price only of the stores (Including duties, taxes) which the supplier has failed to deliver as aforesaid for each week of delay or part thereof, subject to a maximum of 10%. In case of extension of delivery period, increase in taxes shall not be borne by BDL, if delay is attributable to vendor".
