2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - D) I/we the vendor / Bidder understand that any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares land border with India, shall also require to be registered with the same competent authority and we comply with the same as per OM No.F.7/10/2021-PPD dated 23.02.2023.
- E) We, the Vendor / Bidder agree and undertake that if the Purchase order is awarded to us, we will not sub-contract or outsource the order, and / or any part thereof unless such subcontract / outsourcing is permitted by Centre for Development of Telematics (C-DOT) in writing, in which case the aforesaid OM and clarifications shall be equally applicable to such sub-contractor/vendor.
