**1. Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

**2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**3. Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

**4. Generic**

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a) Bidder should have experience of supply or manufacturing of G.I pipes to any industry during last 7 years ending last day of month previous to the one in which applications are invited.
- b) Bidder shall submit at least One PO copy along with Payment Invoice or receipt / Delivery challan/completion certificate indicating purchase order number to verify successful execution of submitted PO.

**\* Technical Conditions:**

1. Bidder shall refer item code description and requirements mentioned in this tender to manufacture GI pipes.
2. Bidder shall submit duly signed and stamped copy of all technical requirements mentioned in this tender as a token of acceptance of technical requirements. Failure to submission of duly signed and stamped copy of all technical requirements will be subjected to rejection of offer.
3. All Pipes shall be rigid, hot-dip galvanized, furnished in standard length of 5.5 to 6 meters and plain at both ends (without any threads).
4. All Pipes shall be hot dip galvanized both on inside and outside as per IS-4736. Test certificate for galvanized coating shall be supplied along with supply.
5. Each piece of Pipes shall be straight, free from blister and other defects, Internal and external surface shall be of smooth finish and covered with capped bushings at both ends.
6. Make of GI pipe shall be TATA/JINDAL/ZENITH or Equivalent make.
7. All GI pipes shall be manufactured as per IS 1239 Part-1 latest revision and shall meet its specification requirements.
8. Bidder shall submit MATERIAL TEST CERTIFICATE of RAW MATERIAL used for all items from NABL APPROVED LAB. (Offer shall be inclusive of all testing charges).
9. Bidder shall deliver the material within 8 weeks from date of PO/LOI placement.
10. Bidder shall provide Guarantee/Warranty certificate for material and workmanship for period of 12 months from commissioning or 18 months from receipt at site which

ever is earlier.
