1. **Buyer Added Bid Specific Scope Of Work(SOW)**

SCOPE OF WORK

- 1.0 The work involves servicing of the equipment and identifying the faults and correction if replacement of spares is not required.
- 2.0 If any spares to be replaced, then the same may be communicated along with the price and on approval, the spares shall be replaced.
- 3.0 On receipt of the equipment, the condition of the equipment shall be recorded and signed by the contractor as well as the person handing over the equipment from NLCIL.
- 4.0 The calibration shall be completed and the value after calibration shall be checked, recorded and certified by the contractor.
- 5.0 The equipment shall be returned in working condition as recorded prior to servicing, along with calibration certificate to the person authorised by NLCIL.

2. **Buyer Added Bid Specific ATC**

SPECIAL CONDITIONS

Part-I

- 1.0 The equipment will be delivered at the contractor address and taken back by NLCIL personnel.
- 2.0 The condition of the analyser after receipt shall be assessed and recorded and duly signed by NLCIL personnel and by the contractor.
- 3.0 The contractor must ensure the safety of the equipment during their custody.
- 4.0 The equipment shall be returned in satisfactory working condition along with calibration certificate to the person authorised by NLCIL.

Part-II

- 1.0 All labour laws, regulations, statutory provisions as applicable towards performance of scope of work outside NLCIL, shall be adhered to by the Contractor only.

NLCIL shall not be liable for any event/action by any authority.

- 2.0 **CONTRACT WORKMEN DEATH RELIEF FUND (CWDF)**

- 3.0 **INDEMNITY BOND**

The contractor shall submit an indemnity bond for value of Rs.3,37,628/- prior to dispatching the equipment along with accessories.

- 4.0 **PRICE REDUCTION CLAUSE**

Time is the essence of the contract. In case the contractor fails to complete the works within the stipulated period, then, unless such a failure is due to Force Ma jeure or due to Purchaser's defaults, the total contract price shall be reduced by ½% (half percent) of the total contract price per week of delay or part thereof subject to a maximum of 5% of the total contract price, by way of reduction in price for delay and not as penalty.

5.0 **GUARANTEE FOR WARRANTY**

In case of replacement of any component or spare, applicable Guarantee for Warranty for a period of six months from the date of receipt of the analyzer at NLCIL shall be provided.

6.0 **CONTRACT PERFORMANCE GUARANTEE**

7.0 **PERIOD OF CONTRACT**

7.1 Four (4) months from the date of commencement of work.

Note:

Lead days of 1 day are provided to the Service Provider for necessary mobilization for offering service. Thus the service start date will commence from minimum 1 day after contract generation date.

7.2 **Period of work:**

30 days from the date of receipt of equipment by the contractor.

8.0 **PAYMENT TERMS**

80% payment including GST shall be made after dispatch of the instrument with accessories. The final bill will be paid after the finalization of contract.

9.0 **GST (Goods and Service Tax)**

Contractor has to furnish the **GST Registration number** with relevant documentary evidence. Contractor has to comply with the GST Act/ Rules.

10.0 NLCIL reserves the **right to short close / extend the contract** due to special circumstances

11.0 The General Conditions clauses 1.0, 2.0, 3.0, 4.0, 5.0, 8.2, 11.0, 12.0, 15.2, 15.7, 22.0, 24.0, 28.0, 35.6, 35.7, 35.11 & 35.19 are not applicable.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs

and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
