#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

#### SCOPE OF WORK/ ESSENTIAL DETAILS OF ITEMS/SERVICES REQUIRED

The successful bidder, hereinafter referred to as the contractor, shall provide Four (04) Veterinary Doctors, four (04) Paraveterinary worker and four (04) Animal Handlers for Animal Husbandry Department, Leh for Animal Birth Control and Anti-Rabies program as detailed in scope of work.

Note: - 1. The contract will be concluded only for the prospective period of the financial year 2026-27.

2. The contractor shall obtain a valid license from the competent Licensing Officer under the Labour (Regulation and Abolition) Central Rules, 1971, within 90 days of the date of this Agreement. If the contractor is refused a license for any reason whatsoever, fails to obtain the license within the stipulated period, this agreement shall automatically stand terminated, and the Government shall be at liberty to recover any losses, if any, from the performance guarantee of the contractor.

## TERMS AND CONDITIONS

1. The bidder's office must be located in UT-Ladakh.
2. For address verification, rent deeds or GST registration: rent agreements are not considered valid.
3. Bidders are required to upload the Employees' Provident Fund (EPF's) Electronic Challan cum Return (EC R) statement of the last year with payment confirmation.
4. Bidders must also upload the Employees' State Insurance Corporation (ESIC) statement of the last year with payment confirmation.
5. The average turnover should be 1.5 crore over the last three years out of the last five years.
6. Completion of similar work experience must be demonstrated as follows: a) 80% in one contract b) 60% in two contracts c) 50% in three contracts
7. Employees shall be deputed to various regions of UT Ladakh for ABC camps organized by the department.
8. The bidder will be responsible for making the not less than mutually agreed payment directly to the supplied employee through NEFT on or before 7th day of each month. There may be occasional delay in releasing payment by this department to the bidder due to contingencies. Payment of remuneration to the employee by bidder should not be linked with receiving of payment from this department and shall be independent.
9. Jurisdiction of the Courts -Jurisdiction of courts for dispute resolution shall be UT Ladakh only.
10. GeM bill uploading and payment/salary to the employees should be made within 3 days of receipt of monthly statement and budget release respectively.
11. The bidder should have experience for similar work (ABC&AR program)
12. ISO - 10667:2011 and ISO 9001:2015 required

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
