02- Bidder must submit audited Balance Sheet for the last 3 financial years (2021-22, 2022-23, 2023-24 and 2024-25). Service contract will not be considered in determining the turnover for eligibility as required above.

03- PAST EXPERIENCE: Bidder should have 3-year Experience. Bidder must have the following work experience in last 3 financial years (2021- 22, 2022-23, 2023-24) on GeM to any state Govt Department.

04- EPBG DETAILS: Electronic Performance Bank Guarantee 5% of estimate bid value required at the time of agreement with winning firm.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
