Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. **MINIMUM WAGES**

The contractor shall comply the provision of contract labour (Regulation and Abolition) Act of 1970 and contract labour (Regulation and Abolition) Central Rules 1971 and other legislations such as EPF & MP Act -1952, Employees state Insurance (ESI) Act-1948 and Minimum Wages Act- 1948, The payment of wages Act -1936 & Rules/ Acts/ instructions enforced from time to time by the Central Governments. The contractor has to pay the staff engaged by him minimum wages of central Govt. for the trade/job.

2. **RATE**

The rate to be paid to Skilled manpower will be as per the existing rate laid down by Central/State labour department for - Area B (circular order No. F. No. 1/27(1)/2024-LS-II Dtd. 25/09/2024 of O/o the Chief Labour Commissioner (Central), New Delhi).

The wage to be paid for the duty performed on National Holiday = two times of normal Daily Wage.

3. **PAYMENT OF WAGES**

i. In case of non-payment of wages or any other dues of any workmen engaged by the Contractor, AAI reserves the right to make payment and to recover the amount of such payment from the Bill of the Contractor or from any amount payable to him under any Contract or as debt payable by Contractor.
