1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. The contractor shall employ sufficient trained man power and T&P so that the work may be completed in time from the date of execution and start the work from the date of LOI/Agreement and work must be completed within the stipulated period.
2. All skilled labours and T&P, grouting material shall be provided by firm and work will be carried out as per RESPO/DVVNL Norms. Rest material shall be provided by the department.
3. The contractor shall be entirely responsible of the material till completion of the work to the satisfaction of the Engineer of Contract and the Concerned Executive Engineer.
4. The contractor shall be solely responsible for any losses/damages to the persons working with/under him and shall have to pay due compensation in accordance with prevailing rules.
5. Regulation of Government/Contractor shall to have group insurance for labours engaged by him and shall have to pay due compensation in accordance with the same. The corporation will bear no responsibility for the compensation to his labours in case of any man handling accident.
6. The contractor shall ensure payment of wages to their labour as per provision of labour act.
7. The contractor shall be solely responsible for any loss or the theft of the damages to the material taken from the DVVNL Agra/UPPCL Lucknow as long as the works given herein are completed to the satisfaction of the corporation representative and accordingly shall have to keep adequate watch & ward any losses damages accident theft etc. to the materials of the corporation.
8. Payment shall be made by the Executive Engineer, Electricity Distribution Division-II, Orai to the contractor after Submission of satisfactory Work completion report & measurement.
9. TPIA INSPECTION:- TPIA Inspection of all works is mandatory under this Agreement/ Tender.

10. Income tax, GST, TDS, Labour cess and all other taxes as per rule will be deducted as applicable at the time of payment from the contractor bills.

11. All latest rules and regulation of UPPCL/DVVNL shall be applicable for completion of work.
