### 13. Buyback for Non PFMS / Non GPA

Buyback for Non PFMS/Non GPA:

1. GST will apply on the value of buyback and separate invoice is to be prepared by Government buyer/Consignee for buyback items offline outside the GeM system. Vendor should work out input credit for that GST applicable on the buy back while quoting the product/services.
2. Input GST Credit consideration by seller- seller shall offer the prices in the bid by the total amount of new goods including GST- total amount of old goods quoted by the firm excluding GST. This is because GST charged by buyer on buy-back value will be available for full ITC (input tax credit) on the hands of bidder. 3. Successful lowest bidder has to provide detailed cost break up of tendered items as well as buy back items separately after award of contract through email to the government buyer/consignee.
4. The seller of new item /service provider shall deposit the cost of invoiced buy back item with GST to the buyer for allowing seller to lift up the material from the buyer/consignee premise.
5. Transportation of buy back items from buyer premises shall be arranged by the seller itself without any extra cost.
6. Government Buyer organisation /consignee will issue invoice of buy back items to the seller at the cost of buyback to be indicated to the buyer by the seller offline after receipt of order. This in no case will modify the bid in any manner.
7. The seller will be entirely responsible for the safe disposal of old items without affecting the environment in any manner as per prevailing statutory rules and Act/ law of the land.

OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 3 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Buyer Added text based ATC clauses

1. **TECHNICAL SPECIFICATION**

**ULTRA SONIC SURGICAL ASPIRATOR**

1. The Ultrasonic surgical aspirator system should be compact with integrated aspiration and low noise.
2. Surgical aspirator should be based on Piezoelectric Technology for tissue fragmentation, offering precise control and minimizing collateral damage.

3. The hand pieces should be slim, compact & light weight design. They should be low heat generation type so that they remain cool even after prolonged period of continuous use. The hand pieces should not require any external cooling material and its design should not be obstructing the surgical field.
4. The hand piece and tips should be autoclavable/ sterilizable. The hand piece/tips must be designed for long life.
5. Following hand pieces (from same company) to be provided and should be upgradable with software and hardware in future :
  - (i) **20-25 KHz for Liver Tissue with open & Laparoscopic tip option.**
  - (ii) It should have separate tough tissue tip for liver resection in the frequency range of 20-25kHz for specific Liver surgery.
  - (iii) Laparoscopic liver tips should be more than 370mm above for long length
6. System must have the tissues electivity or patient safety controls to protect critical structures (vessels, ducts).
7. The quoted handpieces should provide a facility of monopolar coagulation adaptor, if removable then 5 in quantity should be supplied & if it is embedded in handpiece need to provide the warranty for the same until warranty period.
8. Should include a built-in vacuum pump, providing > 500mmHg vacuum (preferably upto 640 mmHg) with low noise and digital display.
9. Pre-aspiration hole design is required to minimize misting, heat build-up, and fluid blockage for enhanced visibility.
10. Handpiece usage tracking and safety check before for each use is desirable for hassle-free workflow.

11. Integrated irrigation pump with adjustable flow rate of 2-25ml/min or more and fast flush function is mandatory.
12. The system needs to support the constant and on-demand aspiration for Laparoscopic surgery.
13. It should have 1.5 - 2.5 Ltr capacity container of unbreakable material with specimen traps.
14. Dual adjustable foot pedal for controlling amplitude and irrigation in on/off or linear mode is mandatory for avoiding human interference.
15. Single average cost of all the available tips mentioned in the brochure, irrespective of size and shape, is to be mentioned. The cost remains to be fixed for the next 10 years from the date of installation of equipment. Tips will be requested on an as and when required basis.
16. Demonstration of equipment to be arranged (mandatory).
17. Additional requirements if any for installation of equipment in a working condition are to be mentioned clearly.
18. Rate of consumables and disposables are to be mentioned and will remain for the next 10 years from the date of installation of equipment.
