Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting

bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

Special Instructions is as follows:

- Compatibility of accessories: The thermocouple tips shall be compatible with the standard accessories viz. contact block, front pipes, MI Cables etc. of Positherm tips of M/s Heraeus Electronite, Belgium.
- Packing and Marking on Boxes:
 - Supply by the vendor shall be made in cardboard cartons containing 50 nos. of thermocouples.
 - The cartons shall be sealed to protect against dust and damage due to ingress of moisture during transit and storage.
 - The cartons shall be identified by:-
 - Name of the manufacturer
 - Type of Thermocouples
 - Batch/Lot No. for easy traceability.

3. Marking on thermocouple sensor insert & assembly
 - a) Each probe shall have marking of the OEM's name on the thermocouple sensor insert for authenticity.
 - b) Each assembled thermocouple shall have suitable marking of supplier's name on the cardboard tube.
4. Certificates and documents along with the offer. Copies of the following that are pre-requisite for considering the offer shall be submitted: -
 - a) In case supplier is not OEM of thermocouple inserts, Latest valid letter by the original Thermocouple sensor insert manufacturer (OEM/Principle) authorizing the tenderer as official user of their inserts for producing thermocouple assemblies and marketing them.
 - b) Currently valid ISO-9001 or equivalent international standard certificate of the insert manufacturer and the certificates of the standards followed.
 - c) Relevant technical catalogues and drawings shall be submitted.
5. Certificates and documents along with each consignment. Supplier shall furnish the following after placement of order: -
 - a) Test certificate by the OEM/Principal manufacturer of the sensor inserts for calibration test results in Palladium bath at 1554deg.C.
 - b) Declaration of the supplier for having used the certified sensor inserts with appropriate batch numbers in manufacturing the thermocouple tip assembly.
 - c) Guaranty/Warranty certificate The supplier shall submit guaranty/warranty certificate for performance and quality of workmanship against each consignment. Whole consignment shall have to be replaced if found defective or below quality norms as specified in SAIL testing procedure.
6. Party has to give certificate complying all technical details & standards as mentioned above.
7. After arrival of material in stores joint inspection shall be done by Instrumentation department and CSD.
8. No of sources will be more than one.
9. Both the Materials to be delivered in staggered manner (10,000 EA / month for Item-1 and 11,000 EA /month for Item-2). Delivery Start date and the Schedule will be mentioned in SAP Backup PO. Schedule mentioned in SAP PO has to be followed.
10. Monthly quota for delivery mentioned in the SAP PO is tentative, depending upon the current requirement and may change with mutual consent of the buyer & the seller.
11. In case of any failure in timely supply by any supplier, DSP reserves the right to divert quantity from monthly quota to other supplier to ensure availability of material without jeopardizing right to DSP for any other course of action as per contract.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
