1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. **Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

6. **Past Project Experience**

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. Any other document in support of contract execution like Third Party Inspection release note, etc.**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. **Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

9. **Generic**

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

10. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

11. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

12. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

- 1) Buyer must be uploaded the following documents:-
  - 1) EPF Registration with last month up to date challan /return.
  - 2) ESI Registration with last month up to date challan /return.

- 3) GST Registration with last month up to date challan /return.
- 4) Valid licence issued by regional labour commissioner.
- 5) Security personnel are required to perform duty in morning, evening, and night shifts, ensuring round-the-clock coverage.
- 6) Financial Bid Restriction: - No bidder shall be entertained if it quotes wages below the prescribed Minimum Wages (including VDA) mandatory contributions towards EPF & ESI and payment of statutory bonus. Service Charges to agency should be quote separately (not clubbed with wages) as per the laws of the Labour Department, Government of Tripura.
- 7) Bidder's Service Support Office Requirement
  - The bidder must have a service support office located in Tripura.
  - Office Address, Person Name with Contact Number,
  - A valid Trade Licence must be submitted .

If the bidder's office is rented, a duly sworn Bhatiya Nama affidavit must also be submitted
- 8) Security Guard Requirements and Duties
  - Security guards must be polite, disciplined, physically fit, and alert, and shall be smartly dressed in proper uniform with a photo identity card issued by the firm.
  - They shall control and restrict entry of patient parties into indoor, outdoor, and administrative buildings without a valid gate pass, to prevent unnecessary gatherings within hospital wards and premises.
  - Guards must maintain strict control of vehicles entering and moving within the hospital premises.
  - They shall respond immediately to any unlawful or untoward incident occurring in the hospital.
  - A daily diary must be maintained to record all important events and happenings, which shall be reported to the controlling authority.
  - The firm shall be entirely responsible for any theft or loss of hospital property occurring during the contract period.
- 9) Rate of Security guard shall be revised as per the labour department Govt.of Tripura notification in time to time.
- 10) If multiple bidders are L1. Same will be selected by the system i. e GeM portal through L1 run method.
- 11) If any Government property is stolen from inside the hospital premises while the hospital security guards are on duty, the Hospital Authority shall deduct the value of the stolen property from the monthly payment to the contractor. The deduction will be made based on the prevailing market value of the stolen items or property.

- 12) If the bidder is an Original Equipment Manufacturer (OEM), the bidder shall be required to submit a valid OEM Certificate or Affidavit. In the event that the bidder is not an OEM, the bidder must furnish an appropriate Authorization Certificate issued by the respective OEM.
- 13) Bidders shall upload only those documents that are relevant and required under the Terms and Conditions of the Bid. All submissions must be clear and of high resolution to ensure proper evaluation. Uploading unnecessary or unrelated documents is strictly discouraged. In the event that a bidder is found to have submitted irrelevant documents, such bidder may be liable for disqualification from the bidding process.
14. Security Guard must perform duties as per Hospital requirements on time to time basis.

## अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.

9. Creating bid for items from incorrect categories.

11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope

of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
