Techno-commercial Evaluation Criteria:

- a. PESO License: vendor should have valid approval from Chief Controller of Explosives / PESO (Petroleum & Explosives Safety Organization) for carrying out the job of STP of cylinders under Gas Cylinder Rules for the premises from where the STP works will be carried out under this tender (i.e. for 425 kg LPG Cylinder/ 990 Litre Water Capacity LPG cylinders). Such license should be valid as on the closing date of tender. Latest editions and revisions, thereafter, need to be followed strictly.
- b. Bidders not having valid approval from CCOE / PESO will not be considered and such bid will be rejected.
- c. Bids of such Bidder not submitting BSD will be summarily rejected.
- d. Bids not meeting the annual turnover requirements will be rejected.

The tender notice is being published for information only and is not an open invitation to quote in this limited tender. Participation in the tender is by invitation only and is limited to the selected approved suppliers. Unsolicited offers shall be ignored. However, suppliers who desire to participate in future tenders may apply with credentials for registration with IOCL.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
