1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 5. ### 1. **Generic**

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. **Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

### 4. **Buyer Added Bid Specific ATC**

2. 1. The manufacturer must have an in-house NABL-accredited laboratory equipped for electrical, photometry, and safety testing at the manufacturing facility, and should be capable of generating test reports.
3. 2. The bidder must submit all relevant certifications, including but not limited to UP PWD CAT, CRS, BIS, TDS, LM-79, LM-80, IP rating, TTC, and Photo biological test reports. These should preferably be from an NABL-accredited in-house or recognized laboratory.
4. 3. The manufacturer should have an in-house PCB (driver) design and manufacturing facility.
5. 4. A 5-year warranty declaration must be submitted on the OEM's letterhead.
6. 5. The manufacturer must have an in-house LED driver (electronics) design and manufacturing facility, along with BIS certification, as the driver is a critical component for maintaining product performance and warranty.
7. 6. As per Government of India norms promoting "Make in India", the manufacturer should have a valid domestic manufacturing facility, supported by a Factory License.
8. • The bidder/OEM must submit valid certifications including:
9. ISO 9001:2015 /ISO 20000-1:2018 /ISO 10667-1:2020 /ISO 10667-2:2020 /ISO 14001 /ISO 27001 /TC 260 Certificate, Non-submission or delayed submission of these documents shall result in disqualification. These certificate must be issued at least 90 days before the date of bid.
10. 7. All bidders/OEMs must upload necessary documents such as warranty details, escalation matrix, toll-free number, and ensure validity during the tender period.
11. 8. The manufacturer must have dedicated service centres to ensure prompt response during the warranty period.
12. 9. The bidder must be authorized by the OEM, and the authorization certificate must be submitted with the bid .A valid OEM Authorization Certificate in the prescribed format must be provided for verification and communication purposes.
13. 10. A Non-Blacklisting and Non-Insolvency Affidavit in favour of the concerned Executive Officer must be submitted on ₹10 stamp paper. A scanned copy should be uploaded with the bid, and the original

- nal must be submitted within 5 days of bid opening.
14. 11. The bidder/OEM must submit an audited turnover report for the last three financial years.
  15. 12. The OEM Make and Brand Registration Certificate must be uploaded.
  16. 13. The bidder must upload statutory and financial documents including PAN, GST registration, work experience, and Income Tax Returns (ITR).
  17. 14. The bidder may submit EMD @2% of Estimated Value in the Bid in the form of an FDR (Fixed Deposit Receipt) pledged in favour of the buyer i.e The Executive Officer, agar Panchayat Rajapur, Chit rakoot. The bank must certify restricted withdrawal conditions. A scanned copy must be uploaded, and the original must be submitted on or before the end of Technical bid,late submitted or delayed s ubmitted emd will not entertained and disqualified.
  18. 15. No exemption to any entity shall be allowed regarding submission of EMD/FDR.
  19. 16. The bidder must submit a sample product before the bid closing date.
  20. 17. The bidder must have prior experience in supplying similar or higher wattage products.
  21. 18. All documents submitted within the Technical Bid must be arranged in a sequential order. If a bidder fails to submit/upload the copies or hard copies of the documents/certificates requested in the bid to the Buyer within 03 days of the bid closing date, the bidder shall be declared technically disqualified and shall not be eligible for financial evaluation. The bidder shall be solely responsible for any disqualification arising during the technical evaluation process.
  22. 19.It is mandatory for the supplier/firm to attach documents such as work orders , payment records, etc. pertaining to any supplies previously made to any government or semi-government organization; furthermore, the bidder must have executed a GeM contract.
  23. 20.It is mandatory for all documents submitted by the firm/supplier to be self-attested and duly certified with an official seal and stamp.
  24. 21.Conditional tenders shall not be accepted.
  25. 22.It is mandatory for the bidder to attach self-attested photocopies of their PAN Card, Aadhaar Card, MSME Certificate, and GST Certificate along with the tender. Furthermore, it is mandatory to upload the relevant GST forms and at least five ATC (Authorized Technical Consultant) certificates along with the tender.
  26. 23.The bid is liable to be rejected if any illegible or unclear scanned copies are uploaded along with the bid submission.
  27. 24.the event of any dispute or litigation, the decision of the Sessions Court, Chit rakoot, shall be final and binding.
  28. 25. . The supplier/firm is required to submit the original copy of the EMD (of which a scanned copy was uploaded with the bid) to the office of the Nagar Panchayat Rajapur (Chitrakoot) after the opening of the technical bids.
  29. 26.The undersigned reserves the right to cancel the tender without assigning any reason

The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
