1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Scope of work & General Terms & Conditions for vehicle hiring:-

This Tender has been executed for, “**Hiring of 27 Nos. A.C. SUV Vehicle for Two Year including driver consumables, maintenance, fuel etc. 2000km×320 Hrs Out Station for the official use of SAG Officers of NER Gorakhpur**”.

1. The vehicle will be used for 27 SAG Officers of North Eastern Railway, Gorakhpur .
2. The service provider shall supply vehicle in good and perfect working condition and vehicle shall be maintained in good condition throughout the period of validity of contract so as to ensure satisfactory service under the contract.
3. Vehicles to be provided by the service provider preferably in white colour and should be in perfectly sound working condition.
4. Vehicles to be provided by the service provider must be mechanically sound and should be maintained at OEM service center as per OEM recommendations, during the contract period for all scheduled maintenance. Vehicle to be maintained in full working condition as originally purchased/ showroom conditions with all feature operations and should be provided with neat and clean seat covers and interior with white towels& air freshener.
5. Service provider shall quote a monthly rate for hiring of vehicles. The rate shall include all of the following:
 - a. All maintenance expenditure of vehicle required for good running of the vehicle and all consumables in addition to fuel.
 - b. Salary and other charges of driver.
 - c. All taxes (Levied by state/Central Government) including Income Tax, GST etc.
 - d. Hiring of vehicles for **12.00 hours per day & 2000kms (Outstation)** per month.
 - e. Any other charges required for execution of this contract.
6. The kilometers for the purpose of “Vehicle run” and “Hours” of duty shall be reckoned from the point of reporting for duty to the point of vehicle released.
7. No mileage will be allowed for Lunch/Tea/Refilling of fuel etc. of the driver.
8. Working hours shall be decided by the user.
9. The duty of the driver in a day will be normally 12:00 hrs. The Vehicle shall be provided to the Users by the service provider in time within 15 minutes as & where vehicle is called by the user. Vehicle will be utilized as demanded by the user. The punctuality must be maintained. The vehicle shall ordinarily not be changed, but may be changed only on the occasion, when the vehicle is liable to send under repair/maintenance. The service provider shall be responsible to provide the vehicle at any time in emergency if called .In emergency, no plea shall be heard.
10. The driver must be well behaved, well-mannered in proper dress and courteous to the Officer. He should have a active mobile connection so that he can be contacted without time wastage.
11. Driver should be in proper and clean dress/clothing, punctual, well versed with Gorakhpur and near by area of Gorakhpur routes and places and also well versed in traffic rules.
12. The service provider is fully responsible to provide skilled driver, who knows proper etiquettes to serve with senior officers in Government Services in all respect.The following condition should be followed by the drivers,
 - a. Daily Grooming and shaving is a must for the drivers, beard if kept should be neatly trimmed.

- b. No driver shall consume Bidi, Cigaratte, Paan, Gutakha, Surti, Tobacco etc during duty hours.
 - c. No driver shall come to duty in an intoxicated state.
 - d. Slim fit, Low waist and short ankle revealing trousers are not to be worn by drivers.
 - e. Due to the nature of duty of railway officers every vehicle should be equipped with an emergency flash light of 1400 Lumen, IP68, minimum 200m Beam distance, rechargeable led torch of make LedLenser (Model P7R core), Fenix (Model TK 20R) etc or Similar.
13. The Vehicle is expected to be utilized during festival also such as Holi, Diwali, Eid & 25 Dec etc due to the nature of the railway working condition. The service provider cannot deny providing vehicle to user on any festival or holiday or Sunday; otherwise, penalty shall be imposed as per GEM terms & condition and recovered from running bill. If the service provider provides any leaves to the driver, the vehicle shall be provided to the user with another driver. In this regard no any plea shall be heard. The Service provider shall manage the driver for attending the users immediately in absence of proper allotted driver/vehicle.
14. The railway reserves the right to terminate the contract at any time without assigning any reason thereof, if vehicle is not required to Railways. Service provider shall not be entitled for any compensation in case of such termination.
15. Successful bidder has to upload details of their LOAs, engaged workmen, wage payment details etc. on monthly basis. In order to ensure the same as application has been developed and hosted on web site www.shramikkalyan.indianrailways.gov.in. Contractor shall register his firm/company etc. and upload requisite details of labour and their payment in this portal. These details shall be available in public domain.
16. Wherever Gem terms & conditions are not clear the same may be clarified from GCC of service contracts 2018. In case of any contradiction between Gem terms and conditions and GCC of service contracts 2018, the conditions of Gem will prevail else GCC of service contracts 2018 will prevail.
17. Railway shall have the right to reject the vehicle if not found suitable as per above conditions.

If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
