Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

TENDER TERMS & CONDITIONS

A) Pre-Qualification Criteria:-

1) Financial Capacity (Annual Turnover):- Average Annual financial turnover of related services during the last three years, ending 31st March of the previous financial year, should be at least 30% (Thirty per cent) of the estimated bid value . This estimated bid value is the cumulative value of the Bid Cart.

2) Work Experience / Project Experience:- The bidder must have successfully executed/completed similar services, (As per scope of work) over the last three years i.e. the current financial year and the last three financial years: - 1) Three similar completed services costing not less than the amount equal to 40% (Forty percent) of the estimated cost; or 2) Two similar completed services costing not less than the amount equal to 50% (Fifty per cent) of the estimated cost; or 3) One similar completed service costing not less than the amount equal to 80% (Eighty per cent) of the estimated cost.

GeM has authenticated experience of participated vendors in Human Resource Outsourcing Category/Technical Manpower Category, which are available in experience certificate window during technical evaluation of bid. The experience certificate has following information i.e. Department Name, value of Project, Project Start Date & Project End Date. Hence this information will be used for evaluation of work experience i.e. 01 order of 80%, 02 orders of 50% & 03 orders of 40 % cost of estimate of this tender/bid.

3) As per Government of India, Ministry of Micro, Small & Medium Enterprises, Policy Circular No. 1(2)(1)/2016-MA dtd-10/03/2016 and Government of India, Ministry of Finance OM No. No. F.20/2/2014-PPD(Pt) dtd- 25/07/2016 & OM No. No. F.20/2/2014-PPD(Pt) dtd- 20/09/2016, MSME & Start-up Enterprises will be given exemption to prior Turnover & prior Experience criteria of this tender. Exemption for years of Experience and Turnover:-An exemption will be provided to verified MSME and Start-ups recognized by DIPP.

4) EMD Exemption:-The bidder seeking EMD exemption must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category, only manufactures for goods and service providers for Services are eligible for exemption from EMD. If firm is not MSE or Startup firm should submit Bid Security Declaration.

5) **The bidder participating in the bid should have Geographical presence i.e. bidder should have office address in Maharashtra State. The bidder has to undertake the same in the bid.**

6) Those vendors who are in receipt of any Supply/Work Order of outsourcing Contract in the Ordnance Factory Dehuroad, Pune and have participated in the fresh outsourcing contracts will be ignored if their bills for service rendered more than 8 months ago have not been submitted.

B) Instructions regarding submission of Bid:-

- 1) **The Service Provider has to provide the I-Cards, PPE's & Uniform as per attached Scope of Work. The bidder shall quote service charge considering the cost of I-Cards, PPE's, & Uniform. No additional payment will be made for same.**
- 2) **Please read the attached Scope of Work carefully before quoting.**

C) Terms & Conditions regarding submission and payment of Bills: -

1) Contractor has to pay wages by 7th of consecutive Month and all the statutory contribution (like EPF, ESIC, Professional Tax, GST etc) by 15th of consecutive month and submit the bills with all documentary evidence to Ordnance Factory Dehuroad Pune for claiming the payment. Contractors submitting bills with insufficient document will not be processed.

2) Contractor has to issue Monthly Wage Slip to every worker/labour to be deployed by them against this Contract. The wage Slip Should showing following details: - Name of Employee, Employee id, Duty days, Minimum wage rate, Gross Wages, details of deductions like (EPF, ESIC, PT, MLWF etc), UAN of EPF, net payment and date of payment.

3) Performance Bank Guarantee (PBG) is to made is favor of "The Chief General Manager Ordnance Factory Dehuroad (Unit of MIL)" and Hard copy shall be sent to "Ordnance Factory Dehuroad, Pune (MH) - 412101"

4) In case of any changes in the minimum wages as per the applicable laws during the contract period, the wages shall be paid to deployed staff at revised rate .

5) Contractor has taken ESIC sub code for Pune Region and issue ESIC Cards for the employee to be deployed by them against this Bid.

6) Those Manpower who are not covered under provision of ESIC (Presently Semi-skilled, Skilled & High-skilled category are not covered under ESIC) are to be insured by Group Insurance by bidder. The Bidder has to submit the Group Insurance Policy with respect to Manpower deployed by them against this Contract with their first bill. The cost of Group insurance may be claimed by Contractor, but this cost will not be more than the 3.25% of the total gross yearly wages of the employees for contract period.

7) Those Labours deployed by Contractor who are not covered under provision of ESIC are to be insured by Group Insurance by bidder. The Bidder will quote the Service Charge keeping in view the cost of Group Insurance. No separate payment will be made for the same.

8) Beyond specified leaves as applicable to the Manpower mentioned in the contract, leaves will be treated as leave without pay (LWP) for which necessary deduction will be made by the Buyer in the amount billed by the service provider, if no replacement of Manpower is provided. For Absenteeism - Penalty @ 10% of total value of absent Man powers (including PF, ESIC and Bonus) during the Month beyond specified leaves will be imposed.

D) General Terms & Conditions: -

- 1) Buyer has right without any prejudice to terminate this Contract or any part by written Notice to a Seller if :
 - Seller fails to comply with terms & conditions of Contract.
 - Requirement of Manpower ceases to exist.
 - Seller fails to deliver the service as per Contract Conditions.
 - Seller fails to pay wages contribute towards ESIC / EPF within prescribed time

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

7. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

8. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

The Chief General Manager / OFDR (Unit of MIL)

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. 8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
