The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

8. Service & Support

9. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. Warranty

Warranty period of the supplied products shall be one years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

12. Buyer Added Bid Specific ATC

13. 15. 16. 17. Successful bidder has to get advance approval of the sample or diagram from the office, before final supply of items.

18. The material shall be supplied on or before 31-07-2026 from the date of issuance of the work order.

19. Payment will be made only when the quality of the material supplied as per the work order is as per the standards of the department.

20. If for any reason the dates mentioned in the tender notice happen to be a holiday, the tender will be opened on the next working day.

21. As per above, the material has been estimated in relation to the physical target allotted to the division, the quantity of material may increase or decrease depending on the budget availability, for which no claim of the bidder will be accepted.

22. If the firm/company is a partnership then it will be mandatory for all the individuals to upload Aadhar Card, PAN Card and Partnership Deed.

23. The undersigned reserves the right to reject any or all the bids without assigning any reason.

24. The Buyer will verify all documents submitted by the participating reseller company, and if any document is found illegal the bidder will be blacklisted and/or face legal action; it is mandatory to upload a ₹100 notarized and attested De

claration of Non-Blacklisting, No Criminal Record, and Not Being Registered with the Bar Council, and the bidder also declares having good reputation and conduct in the NAGAR PANCHAYAT KOIRIPUR SULTANPUR and other Department (Bid Effective Date).

25. It will be mandatory for the company/firm/individual firm to attach the certificate to give the name of the firm, Current Place of the office, mobile Number and account Holder bank Details.
26. The bidder should have experience in construction work and must have successfully completed at least one similar work during the last five financial years, having a value not less than 80% of the estimated cost of the bid.
27. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document Quality Management System Certificate, Environmental management systems Certificate and MSME registration.
28. The bidder shall have to confirm that bid over all conditions is acceptance must be uploaded on Letterhead and the bidder has to delivery of hardcopy to the buyer within 5 days of bid end date / bid opening date.
29. Net Worth of the Bidder should be positive as per the last audited financial statement.
30. To be eligible for award of contract, bidder must possess following certificates uploaded with bid document, 2024-25 Balance sheet and Profit & Loss and 2025-26 ITR Return.
 31. Queries or objections may be submitted only within the bid date and the prescribed time period. Any complaint received after the closure of the bid or at the time of bid opening shall not be considered.
 32. In case the L1 bidder selected through the GeM portal fails to submit a valid similar work experience certificate in the concerned office within the stipulated period of 48 hours, the bid of the L1 bidder shall be disqualified.

If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
