1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Bidder has to submit EMD through DD/FDR/BG pledged in favor of Executive officer, Nagar Palika Parishad Manuranipur. The Bidder will upload the scanned copy of the instrument along with the technical. EMD Submission mandatory for all bidder.
2. Notarized Affidavit by the bidder & OEM stating that have not been Black listed or De-Barr ed & no any pending blacklisting court pending cases with any Central/State Government Authority/ Department in previous history.
3. The Bidder/OEM should have ISO 9001:2015 (Quality Management System), ISO 14001:2015 (Environment Management System) ISO 45001:2018 (Occupational Health & Safety Management System) ISO 5001:2018 (Energy Management System) certification by IAF Approved bodies.
4. The Bidder/OEM should have successfully completed similar work during last 03 (Three) years with any Government/Semi Government/ULB in India ending last day of Month previous to the one in which applications are invited should be either of the following :-
 - a) The Bidder/OEM should produce credentials of a similar nature of completed work of minimum value of 35 % of bid amount or
 - b) The Bidder should produce credentials of 2 (two) similar nature of completed work, each of them having minimum value of 20 % of bid amount or
 - c) The Bidder should produce credentials of 3 (Three) similar nature of completed work, each of them having minimum value of 15 % of bid amount.

Work Order along with supply proof to be attached with technical bid.

5. Bidders/OEM should have an Average Annual Turnover of value not less than 50% of B

id estimated value during last three financial years. A Turnover Certificate issued by Chartered account with mentioning UDIN, to be attached.

6. The Bidder/OEM should have GeM Silver/Gold Certificate, Valid GeM Assessment report .
7. The equipment offered shall be with a Minimum local content of 50% (Class-I) as per Government order No. P-45021/2/2017-PP dated 16.09.2020. The Bidders shall upload component wise documentary evidence for local content of minimum 50% (manufactured within India) under MAKE IN INDIA by self-certification/ undertaking that the equipment offered meets the required local content.
8. Availability of spare-parts of the vehicles/Equipment including spare-parts of the hydraulic and pneumatic systems must be assured for minimum 10 years. Undertaking in this regard must be submitted by the OEM along with the bid.
9. The Bidder is required to upload, along with the bid, all relevant certificate such as BIS Licensee, Type test Certificate, approval certificate, and other certificate as prescribed in the product specification given in the bid document.
10. Availability of services centers: Bidder/OEM must have a functional services center in the state of each consignee's location.
11. Bidder financial standing:- The bidder should not be under liquidation court receivership or similar proceeding should not be bankrupt. Bidder to upload undertaking to this effect with bid.
12. Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regard GST reimbursement will be as per actual or as per applicable rates (whichever is lower). Subject to the maximum or quoted GST%.
13. Warranty period of the supplied products shall be start from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply) at consignee location, OEM warranty certificates must be submitted by successful bidder at the time of delivery of goods. The seller should guarantee the rectification of goods in case of any break down during the warranty period. Seller should have well established installation, commissioning training trouble shooting and maintenance service group in India for attending at after sales services.
14. Dedicated/Toll free telephone no for service support: Bidder/ OEM must have dedicated/Toll free telephone no for service support.
15. Data sheet of the products offered in the bid are to be uploaded along with the bid documents. Buyer can match and verify the data sheet with the product specifications offered. In case of any un-explained miss-matched of technical parameters the bid is liable for rejection.
16. Imported products: - in case of the imported product, OEM or authorized seller of OEM should have registered office in India to provide after sales service support in India. The certificate to this effects should be submitted.
17. Installation commissioning testing configuration training of any whichever is applicable as per scope of supply is to be carried out by OEM/OEM certificate resource or OEM authorized re-seller.

18. Option clause:- The purchaser reserve the right to increase or decrease the quantity to be ordered up to 25% of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% for contacted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.
19. Scope of supply (Bid price to include all cost components): Supply installation testing commissioning of goods and training of operators and providing statutory clearances required (If any).
20. Successful bidder will have to ensure that adequate number of dedicated technical service personals/engineers are designated / deployed for attending to the service request in the time bound manner and for ensuring timely servicing / rectification of defects during warranty period, as per service level agreement indicated in the relevant clause of the bid.
21. Timely servicing / rectification of defects during warranty period: after having been notified of the defects / service requirement during warranty period seller has to complete the required service / rectification within 15 days' time limit if the seller fails to complete service / rectification with defined time limit a penalty of 0.5% of unit price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the buyer directly else the buyer shall have a right to recover all such penalty amount from the performance security (PBG). Cumulative penalty cannot exceed more than 10% of the total contract value after which the buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the seller besides forfeiture of PBG seller shall be liable to reimburse the cost of such service / rectification to the buyer.
22. The bidder is required to upload along with the bid all relevant certificates such as BIS license type test certificate approval certificates and other certificates as prescribed in the product specification given in the bid documents.
23. The successful bidder has to supply all essential accessories required for the successful installation and commissioning of the goods supplied. Besides standard accessories as per normal industry practice following accessories must be part of supply and cost should be included in bid price: COST SHOULD BE INCLUSIVE OF ALL.
24. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the bid documents. ATC and corrigendum if any.
25. Purchaser reserves the right to cancel / scrap the GEM e-bid without assigning any reason at any stage.
26. For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria
 - a) Purchase order copy along with invoice with self-certification by the bidder that supplied against the invoice have been executed.
 - b) Executed certificate by client with order value.
 - c) Any other document in support of order execution like third party inspection release note etc.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The

Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
