1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.  
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /

Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

6. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

##### 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

##### 3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 4. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 5. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 6. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

### **Additional Terms and Conditions (ATC)**

The vehicle to be provided should be in good condition, preferably brand new.

The vehicle shall be at the disposal of the O/o ITO Shajapur for all days of the month.

Contracted hire charges include monthly charges of driver, repairs & maintenance of vehicle, insurance, petrol/diesel and any other incidental expenses in running and maintenance of car.

In case of any accident or any other contingency, and claim arising out of it shall be borne by the vendor only and no whatsoever shall be borne by this department.

The vehicle will be kept neat & clean, in perfect running conditions and should be provided with neat & clean seat covers or mats etc.

If the vehicle is out of order, the vendor shall provide the substitute vehicle immediately. In case, the vehicle does not run on time/at all, the department will have the right to terminate the contract immediately.

The driver running the vehicle should have valid DL and the vehicle should be registered with the concerned authority Central/State Govt. and have a valid permit. A certificate in this regard should be provided.

The driver of the vehicle must follow the traffic rules and other regulations prescribed by the Govt. from time to time.

The driver must observe all the etiquettes and protocol while performing the duty. He must be neatly dressed, should

proper uniform and must carry a mobile phone in working condition, for which no separate payment shall be made by the department.

The vendor and driver shall be bound to obey the instructions of the department as well as the officers assigned to the vehicle.

Dedicated vehicle and driver must be provided and changes will be allowed in exceptional circumstances.

The ITO Shajapur reserves the right to accept/reject any of the bid/quotations without quoting any reason.

The vendor with maximum experience of running vehicle with this department will be given priority (Supportive documents may please be enclosed for verification).

The vendor upon the award of contract will be required to give initial deposit of Rs.10,000/- (Returnable without interest on the completion of contract).

Dedicated office of the service provider must be available within 10 kms range of the O/o ITO Shajapur [Near station Shajapur (M.P.)] for immediate service support, as the vehicle is solely deputed at Shajapur station and necessary documents in this regard may please be enclosed for verification. This is the most important condition for hiring the vehicle, so the required proof may kindly be enclosed for verification, absence of relevant documents is liable for rejection..

Letter of appreciation from the department i.r.o. good & satisfactory service will be preferred.

All the listed ATC plays the major role in selecting/hiring the operational vehicle.
