## 1.2 FINANCIAL CREDIBILITY:

- (i) Turnover: The tenderer should have achieved a minimum gross turnover of **Rs.1,30,00,000/- (Rupees One Crore Thirty Lakhs Only)** per annum in his/her business (in the same name in which he/she is submitting his/their offer) during any one of the previous four financial years i.e. **2022-23, 2023-24, 2024-25 & 2025-26** in the same name/firm composition in which he is applying for this tender. In case of change in the name of the firm/company due to merger/acquisition/take over, the documentary evidence in support of the same should be furnished.

Audited copies of the Balance Sheets and Profit & Loss Accounts for years **FY 2022-23, FY 2023-24 and FY 2024-25** should be duly attached. **However, unaudited reports certified by chartered accountant/Chartered Accountant's Certificate for FY 2025-26 shall be accepted.**

- (ii) Networth: The tenderer must have a positive net worth based upon latest completed (audited) annual accounts.

## 1.3 VEHICLES/TRAILERS OWNERSHIP

1.3.1 The minimum number of vehicles required to be owned/hired and deployed for carrying out the work tendered for, are described in para 3 of ATC II on Scope of Work. A part of the vehicles, as specified in the same para, must be owned by the tenderer, in the name of the owner/firm (in case of proprietary firms), in the name of the partner/firm (in case of partnership firms) or in the name of company or any one or more directors of the company (in case of a company) at the time of bidding.

1.3.2 Bidders who do not own the vehicles/trailers of required model (year of manufacture) as specified in the tender document at the time of bidding but are in ownership of required number of vehicles of lesser model (year of manufacture) to fulfill the minimum eligibility criteria can also participate in the bidding, provided they give an undertaking to the effect that in case they are declared successful and the contract is awarded to them, they bind themselves to purchase (have the ownership in their name) and deploy the vehicles of required vintage (year of manufacture) from date of com

mencement of contract to fulfill the minimum ownership criteria as laid down in the tender document.

Note: In case of 1.3.2 above, the model (year of manufacture) of vehicles/trailers in their ownership on the date of bidding should not be more than three years older than asked for in the tender document. (Example: In case vehicles of "2023 or later" make are asked for in the tender document, the bidder must have ownership of at least 2020 or later make required number of vehicles. Vehicles older than that will not be considered).

1.3.3 At the time of deployment, the actual vehicles deployed may differ from the details submitted at the time of bidding. An option of giving a fresh deployment plan would be available to the successful tenderer at the time of issue of LOI. However, the minimum eligibility criteria with respect to make model etc. will have to be adhered to. The changed deployment plan should be duly approved by the Tender Accepting Authority, whose decision shall be final.

1.3.4 Rest of the vehicles/trailers could be on hired basis, for which, the tenderer should submit a consent letter from the owners for the use of such vehicles/trailers by the tenderer(s) during the entire duration of the contract (contract period of Five (05) years and obligatory period of four (04) months).

1.3.5 The tenderer must submit detailed deployment plan in the requisite format (Annexure V) for the vehicles/trailers asked for in the tender along with consent letter from owners of hired vehicles/trailers (Annexure IV).

Further, GeM reserves the right, at its sole discretion, to cancel

However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
