1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- The contract is for a period of one year initially and can be extended upto one year based on the performance of the service provider on mutual consent.
- The Security Deposit of 5% of the bid value should be submitted in the form of Demand Draft in favour of ESIC Fund A/c No. 1, Payable at Tirunelveli.
- Payment shall be made on quarterly basis based on the satisfactory performance of the service provider after submission of invoice and service reports as per the bid requirements.

PEST CONTROL SERVICES

1) Pest control is an integral component of sanitation services. The following types of pest control services shall be provided by the contractor:

1	Rodent control	Eliminating and preventing rat and mouse infestations using glue Pads/bait-stickers /etc.	52

- 2) The pest control services shall be generally provided for the basement and three floors of the hospital with total plinth area of 8832 (area in sq. mt) However, any area within the boundary walls of the hospital premises shall be treated for pest control, as and when required by the hospital.
- 3) For pest control services, only those chemicals should be used in hospital setting, which are fit for use in healthcare setting. Details of chemicals should contain - Name of chemical, Name of company, Concentration, Chemical composition, Quantity consumed, Size of packing, Batch no., Manufacturing & Expiry date.
- 4) All Chemicals shall be provided by the contractor. The chemicals must be certified by WHOPEs, CIB or BIS. The contingency and evacuation plan must exist for chemical overdose. A small stock of antidote shall be maintained by the contractor onsite.
- 5) There shall be no open baiting. Periodicity of spraying chemicals shall be done to ensure the quality of the pest control.
- 6) The contractor shall employ experienced & certified pest technicians for the work of pest control.
- 7) The contractor shall share the technician details to the hospital administration before each visit for pest control. The hospital will provide free access to all parts of the premises to the contractor for conducting inspection and treatment.
- 8) The pest control should be performed during hours with minimum risk to patients and staff as per requirement of the hospital; post-treatment cleaning being mandatory.
- 9) The logbook and service reports copy for all pest control treatments must be maintained onsite and be available with the Caretaker for inspection on demand. The original service reports along with copy of logbook must be presented with the monthly bill for pest control services.
- 10) If a relapse occurs during the contract period, the contractor is obligated to provide a free-of-cost service to remove the pests. This service must be provided within one day of the complaint raised by the hospital.
- 11) The contractor shall be responsible to arrange its own manpower, tools, chemicals, etc. required for pest control services. The payment for pest control shall be made on the basis of price quoted as per Financial Bid and that will include charges for all the above components of service/ pest control treatments.

SPECIAL TERMS & CONDITIONS

AREA OF WORK: 8832 (area in sq. mt)

All open and covered area within the boundary of the ESIC Hospital Tirunelveli-and- including the basements, open areas, terraces and roof will be in the scope of Pest Control services to be provided by the contractor.

1)Pest and Rodent Control Services:

- (a) The entire hospital including parking spaces, drive ways, wards, ICUs, office rooms, store rooms, sterile areas, Operation theatres etc. are included in the scope of contract for Pest and Rodent Control Services.
- (b) The Contractor shall take effective measures for Rodent, Lizards, other reptiles and Disinfection Services including fogging etc. in the area under contract at least once a week.
- (c) The contract shall do regular fogging in and around entire campus to prevent mosquito menace as per requirement but not less than once in a week.
- (d) The Contractor shall use chemicals that are harmless to humans and machines and treated area. MSD S (Material Safety data Sheet) report of these chemicals should also be attached. These chemicals, tools required for pest and rodent control and man power needed has to be arranged by the contractor himself.
- (e) The Contractor will be responsible for any damage to human/machinery by any chemicals used by him. Any damage caused to machinery/books due to rodent and disinfection services in the areas covered under contract shall be made borne by the Contractor.
- (f) The Contractor will submit a detailed plan for carrying out the Pest and Rodent Control Services for the approval of ESIC Hospital Tirunelveli.

(g) The contractor shall provide good quality gum pads/metal cage traps/pepper mint oil for rodents at places/sites as and where required.

(h) In case of any fault event of sighting /notice/ occurrence of pest, rodent infestation a penalty of Rs. 1,000/- (Rupees One thousand only) shall be levied on every such occasion.

2. Pest Control Monitoring and Control:

For better management and smooth services, the following monitoring mechanism will be adopted by the Contractor:

(a) Management / Pest Control Service Requirements/ Complaints Report: This is to be filled up by the management and administrative staff of the Contractor who receive/observe the complaints/requirements for any of the services. All suggestions, complaints related to services or staff deployed by the Contractor will be registered at site on the computer/register provided to the Contractor and reported to Caretaker, ESIC. The Contractor will take immediate action to resolve the same failing which the Penalty of Rs. 1000/- per complaint will be invoked.

(b) Pest Control Services Complaint Register: This register is to be completed on the basis of information received by the Pest Control Manager from ESIC officials through the inspection of the site, material on site, necessary action is to be taken. attendance sheet of the staff, weekly report, client letter/fax/e-mail, verbal complaints from ESIC, etc.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its

outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
