Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 5. Text Clause(s)

This custom bid has been floated on the basis of GCC for services 2018 and the latest guidelines. The eligibility of the bidders will be evaluated only on the basis of the conditions as mentioned in the tender document attached in Buyer added bid specific ATC.

NOTE:- The Schedule of rates/ Bill of quantities is divided into two schedules. Schedule A pertains to manpower cost which is fixed as per minimum wage criteria, EPF, ESIC, Bonus and Leave pay rules. The minimum wage rate has been considered from CLC rate vide file number 1/6(3)/2025-LS-II dated 30/03/2026. This cost as mentioned in schedule A is considered as threshold value for this tender and any bid submitted below this minimum value of Rs. 7146072/- shall be summarily rejected. In case the contract is awarded at a rate above the minimum threshold value then the minimum threshold value of Rs. 7146072 will be considered as a mandatory part of rate for schedule A. The remaining amount of contract value after deduction of the minimum threshold value of Rs.7146072 will be divided as rates for schedule A and B on a pro rata basis considering the Schedule of rates/Bill of quantities estimates. So the final rate for schedule A will be the sum of minimum threshold value and the pro rata rate for schedule A arrived as above. The rate for schedule B will be the pro rata rate arrived as above.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
