1. This office reserves the right to terminate the contract for deployment of vehicles at any time without any notice.
2. This office may hire higher or lower number of vehicles in any given month, depending on operational requirements. However, the total cumulative distance traveled over the entire contract period of 24 months shall not exceed the overall limit of 7,20,000 kilometers. Variations in monthly vehicle usage or distance traveled may be adjusted in subsequent months, provided that the total distance covered during the 24-month period remains within the prescribed limit.
3. The vehicle will be hired on 24*7 basis, and shall operate within the state of Bihar. The vehicle has to operate within the city and also has to travel across the state of Bihar, as and when required.
4. The "Hiring Contracts" shall be comprehensive in nature and shall include all the costs i.e. maintenance of the hired vehicle, salary of the driver, fuel, toll, parking charges etc. during the currency of the contract at the exclusive risk, responsibility and cost of the contractor.
5. The firm/transporter has to maintain proper Log-Book to show Mileage travelled. For each and every trip, the in and out time and opening and closing meter readings should be recorded by the drivers and countersigned by the users or any person authorized by the office.
6. The opening and closing meter readings should be recorded by the drivers at office premises or designated place of closure of duty."
7. The bidder should have its registered branch/office at the state of Consignee during currency of the contract.
8. The Bidder must be registered with the Income Tax, Goods and Service Tax and also registered under the Labor laws and other authorities as applicable.
9. The bidder must be registered with the concerned authorities for plying in the State of Bihar.
10. Attending pre-bid meeting on schedule date and time is mandatory. An Attendance certificate shall be issued by this office to the participating bidder(s), which must be submitted along with the bid as proof of participation.
11. The bidder should not be under liquidation during last 5 years by any Govt. Department (Central/State/PSU). Bidder to upload valid undertaking to this effect with bid.
12. The vehicle deployed shall be parked at the Buyer's/ User's premises after the duty hours if desired so by the Buyer/ User and cannot be taken-out without written permission from the Buyer/ User.
13. RC and Photos (Color photos only) of all the vehicles must be attached with the Bid document. During the examination of the technical bids, bidder/service provider (only those whose technical bids are otherwise complete in all aspects) must make their vehicles (w

hose details have been provided in the bid document) available for inspection in the premises of Karpoori Thakur Sadan, Ashiyana Digha Road, Patna. The said date and time for the inspection of the vehicle will be intimated separately. Only after the inspection of the vehicles, the technical bids will be considered as eligible.

14. Vehicle registration must be commercial. (Proof should be attached with the bid).
15. All the vehicles whose details are provided by service provider in the Bid document must be attached with the service provider. (Proof should be attached with the bid)
16. The service provider/bidder should also submit a certificate regarding satisfactory service from at least 2 government departments. Further, there should not be any adverse remarks /breach of contract conditions against the bidder/service provider. An undertaking in this regard should also be attached with bid documents.
17. The Company/Firm should have been ISO Certified in providing of vehicles in Govt offices State/Central/PSU on monthly hiring basis. (Proof should be attached with the bid).
18. Service Provider should have minimum 3 years of experience in providing the services of the vehicles on monthly hiring basis to Govt Departments/PSUs. (Proof should be attached with the bid). If exemption is sought for MSME, necessary certificate must be attached with the technical bid. 19. The successful agency should deposit Performance Bank Guarantee @5% of total contract amount valid for initial 26 months within 07 days from the date of award of the contract. The PBG must remain valid during currency of the contract and extended period of contract, if any.
20. Bidder's offer is liable to be rejected if they don't upload any of the certificate/undertaking/documents sought in the Bid document, ATC and Corrigendum, if any.

Scope Of Work For Hiring Vehicle For Census 2027

1. The contract will be for a period of two years from the date of hiring of vehicle which can be extended further for subject to satisfactory performance of the firm followed by the approval of the Competent Authority.
2. The vehicle is to be hired for Officials of Directorate of Census Operations Bihar, Patna in connection with their Official work and Officials assignments. Mileage of the hired vehicle will be counted accordingly. The vehicle is to be hired in connection with training, field supervision work and other activities pertaining to Census of India 2027 for a period of 24 months from the date of hiring.
3. The "Hiring Contracts" shall be comprehensive in nature and shall include all the costs i.e. maintenance of the hired vehicle, salary of the driver, fuel, toll, parking charges etc. during the currency of the contract at the exclusive risk, responsibility and cost of the contractor.
4. The rates to be approved on the basis of Bid received shall be valid for the whole period of the contract and no upward revision will be allowed during the period of contract under any circumstances. It shall be responsibility of the

service provider to carry out the requisite service throughout the period of contract. This office shall bear no cost for anything what so ever with effect from the date of hiring.

5. The approved rates will be applicable within the state of Bihar. The hired vehicle should have valid permit to operate across the districts of Bihar state.
6. The vehicle has to operate mostly within the city but has to travel across the state of Bihar, as and when required.
7. The vehicle is to be hired for maximum 5000 Kilometers per month per vehicle.
8. The vehicle shall report as per time schedule given to the individual driver by the user/Authority as when required positively. Further, additional vehicle may be provided at the same rate as per requirement of the Directorate keeping in view of Census 2027 work.
9. The vehicle to be provided must be in good condition and preferably should not be bought before 2024. The vehicle must be kept in good running condition and it will be clean upholstery with white covers and other accessories of the vehicle will also be kept in good condition. Vehicle with damaged body due to accidents etc shall not be accepted. All the items used in the car i.e. tissue paper, towel, air freshener, curtains etc. will be arranged by the service provider only.
10. Hiring of Electric/CNG vehicles, wherever possible, may be preferred.
11. The vehicle should be insured comprehensively and should have necessary permits from the concerned Transport Department/Authority. This office will not be responsible for any challan, damage, injury, accident etc. to the vehicle or to any other vehicle or person.
12. The firm should ensure that the driver provided must possess valid driving license with **minimum three years' experience** and carry with him all necessary documents like Registration Certificate, Insurance papers, Pollution Control certificate etc. Change of vehicle/driver will be allowed only in exceptional circumstances and that too with prior approval/intimation. Drivers shall have a police verification certificate.
13. The firm/transporter must have all requisite clearance certificates from the concerned Government agencies as required under relevant rules.
14. The firm/transporter **has to maintain proper Log-Book to show Mileage travelled**. For each and every trip, **the in and out time** and opening and closing meter readings should be recorded by the drivers and countersign by the users or any person authorized by the office.
15. The opening and closing meter readings should be recorded by the drivers at office premises or designated place of closure of duty.
16. The driver of the vehicle must follow traffic rules and other regulations prescribed by the Government from time to time. Driver should be familiar with all important routes in the state of Bihar.
17. The driver must always be in clean clothes, must be courteous and well-mannered and should always carry a mobile phone with him for easy contact. The driver must not have any criminal record.
18. The service provider must ensure compliance of labour laws i.e. the legal rights of drivers must be protected.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
