OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

1.1 Agency should submit the **technical specification / relevant catalogue of the item and indicate the offered model/Make in the technical offer/bid.**

1.2 **Agency should submit the duly signed copy of BEL specification/tender document** indicating that they have read, clearly understood & accepted the requirements.

1.3 Agency should submit **duly filled supplier compliance** for commercial terms and conditions in the technical bid.

2. **Payment:**

2.1 For MSME Vendors :-

90% payment will be made within 30 days from the date of supply & Acceptance of item at BEL site. Balance 10% will be released after completion of Installation & Commissioning satisfactorily with due certification by Engineer-in-charge against submission of Bank Guarantee for 5% of order value (excluding GST) towards performance bank guarantee valid for warranty period subject to bank confirmation

2.2 For Non-MSME Vendors :-

80% payment will be made within 30 days from the date of supply & Acceptance of the item at BEL site. Balance 20% will be released after completion of Installation & Commissioning satisfactorily with due certification by Engineer-in charge against submission of Bank Guarantee for 5% of order value (excl

uding GST) towards performance bank guarantee valid for warranty period subject to bank confirmation.

- 3 **Bank Guarantee (BG):-** The Successful tenderer shall submit the Bank Guarantee for 5% of order value excluding GST. The validity of the BG shall be up to expiry of warranty period plus 3 Months claim period.

Note : If the agency not willing to submit the bank guarantee as above , then 5% of order value excluding GST will be deducted from the bills submitted by the agency as security deposit and same shall be released after completion of the warranty period against due certification by Engineer-In-Charge.

- 8 **Warranty:** 12 Months from the date of Installation.

Note: Any Technical issues occurs during the warranty period it should be resolved from Supplier end at free of cost.

9. **Validity of the price:-** The quotation must remain valid for a minimum period of 90 days from the closing date.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
