1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned

Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Invitation to Bid-

Chief Medical Officer District Ambedkar Nagar, Uttar Pradesh, hereinafter known as the Nodal Authority, invites Bids through GEM Portal from eligible Agencies of Taxi/ Vehicle FOR RBSK Programme under NHM U P. The Bidders are being provided with this Bid Data Sheet (BDS) comprising of important, factual data on the Bid below.

2. Eligibility Criteria

- 2.1 Service Provider should be a registered travel agency/firm/society/company/trust.
- 2.2 Taxis should be registered as taxi with RTO with valid permit.
- 2.3 Service Provider should be registered with Service Tax Department/Income Tax Department.
- 2.4 Service Provider with annual turnover of Rs.100.00 LAKHS- or above in last 3 years.
- 2.5 Experience with government departments/public sector undertakings shall be given preference.
- 2.6 Service Provider should have Status certificate issued by District Magistrate which is not less than 25 Lakhs.
- 2.7 Service Provider must have its own Service center or workshop in District head quarter Ambekarnagar.
- 2.8 Drivers provided shall have valid transport driving license.
- 2.9 That the service provider must have ownership of minimum 25% vehicles registered under Taxi (commercial vehicle) & duly insured. The service provider has to submit model, year of manufacture, registration no, Insurance, owner name & address of all the vehicles.
- 2.10 For remaining vehicle if they are being provided by other owner then the owner has to give letter that the vehicle will remain attached with the service provider during the period of contract. That the Taxi vehicle should not be manufactured and registered before the year of 2022.
- 2.11 The vehicle must be GPRS equipped. The data of GPRS must be submitted along with the invoices to CMOS.
- 2.12 The Vehicles allotted under the Supportive Supervision Programme, and deployed to different Blocks under Medical Officer Incharge and at Distt. HQ as well.
- 2.13 The vehicle for SS Programme will be working for minimum 25 days, in case the SS Team unable to visit the vehicle could be used for other assigned administrative work.
- 1.1 Brief profile of the Service Provider.
- 1.2 Attested copy of registration as travel agency/firm/trust/company.
- 1.3-Attested photocopy of Audited Balance Sheet with P&L account for the last 3 years for turnover financial status etc.
- 1.4-(1) that the service provider must have ownership minimum 25% vehicles registered under Taxi (commercial vehicle) & duly Insurance. The service provider has to submit model, year of manufacture, registration no., Insurance, owner name & address of all the total no. of vehicles.
- (II) That if among these total no. of vehicles registered under tax (commercial) vehicle are being provided by other owner then the owner has to give letter that the vehicle will remain attached with the service provider during the period of contract.
- 1.5-Attested photocopy of paper regarding Insurance of all the vehicles. Attested Photocopy of commercial permit of all the vehicles, make model should be of 2022 or later.
- 1.6 Attested photocopy of Status Certificate not less than 25 Lakhs issued by District Magistrate.
- 1.7 Valid document or photographs of Service Center at Ambedkar Nagar district head quarter.
- 1.8 GST Registration Certificate and last payment certificate of last 3 months.
- 1.9 EMD for Rs 1% of estimated project value. per in the shape of DD/ Bankers Cheque or pay order drawn on any bank, in favor of "Districts Health Society District Ambekar Nagar payable at District Ambekar Nagar. Scan copy of DD/ Bankers Cheque shall be uploaded on the portal and submit the original before the time of technical bid opening
- 1.10 Affidavit from Notary about non-blocklisting of agency/firm/company/trust as per format provided at Annexure-II
- 1.11 RFP document duly signed and stamped by the bidder as a token of acceptance to all our terms and conditions..
- 1.12 List of Departments where worked during the last one year.
- 1.13 Attested copy of PAN Card & Registration with Service Tax department.
- 1.14 ANTI-COLLUSION CERTIFICATE on the letter heads per format provided at Annexure I.
2. The bidder should quote the rates in figures as well as in words. Alteration, if any, unless legibly attested by the supplier, with their full signatures shall invalidate the bid. Each page of document should be signed by the supplier himself/themselves or his/their authorized agent on his/their behalf. In case the agent signs the document, the authority letter in his favor must be enclosed with the quotation.
3. The bidder should take care that the rates /amounts are written in such a way that interpolation is not possible. No blank should be left which would otherwise make the bid liable for rejection.
4. The price offered by the bidder shall be valid for a minimum period of 02 years from the date of issue of award of contract and its acceptance by the agency.
5. The tenure of the hiring of services can be extended for a further period if required on annual performance basis on the same terms and conditions provided both parties are agreeable to the same.
6. The agency submitting his bid would be deemed to have considered and accepted all the terms and conditions. No enquiries, verbal or written shall be entertained in respect of acceptance or rejection of the

bids.

7. DHS-NHM reserves the right to cancel/reject full or any part of the tender, without assigning any reason.
8. Any action on the part of the bidder to influence anybody of DHS-NHM will make his bid liable to rejection.
9. DHS-NHM may, in writing, make any revision or change in the order including additions or deletions from the quantities mentioned in the tender document that shall be communicated by DHS-NHM.
10. DHS-NHM reserves the right to cancel the rate contract in whole or any part thereof and shall be entitled to revise the rate contract wholly or in part by a written notice to the selected agency bidder, if
 - a) The agency fails to comply with the terms of the order including specifications and other requirements;
 - b) The agency becomes bankrupt or goes into liquidation;
 - c) The agency fails to provide the Taxi Vehicles on time.
 - d) A receiver is appointed for any of the property owned by the agency.
11. Upon receipt of the said cancellation notice, the agency shall not provide any services connected with the rate contract.
12. Earnest money of Rs 1% of estimated project value. per shall be paid in the shape of Bank draft drawn on any nationalised bank in favor of "District Health Society, District-Ambedka Nagar payable at District Ambedkar Nagar valid for 90 days from the date of opening of technical bids, Scan copy of DD shall be uploaded on the portal and submit the original before the time of technical bid opening.
13. DHS-NHM reserves the right to forfeit the earnest money if any wrong declaration/ commitment by the bidder is found at any stage or fails to execute the rate contract, if awarded.
14. The security/EMD furnished by the bidders will bear no interest. The EMD of unsuccessful bidders shall be returned back within 30 days of opening of financial bids and of successful bidders will be returned upon submission of Performance Security as mentioned in clause 28.
15. The price shall remain firm and will not be subject to escalation of any description during the execution of the rate contract. The rate's offered by bidder shall include all applicable taxes/duties (Central and State GST) as per given scope of works. Also the rate/s offered by bidder shall be inclusive of all fuel charges, cost of driver and maintenance charges of the Taxi vehicles provided by you and no other charges will be payable to you by DHS-NHM. There will be no change in the price in respect to change in the cost of materials, labour/ transportation and/or variations in taxes, duties and other levies on raw materials and components that may take place while the rate contract is under execution, even if the execution of the contract is delayed beyond the period mutually agreed upon.
16. DHS, NHM may at its discretion increase or decrease the no. of taxis running daily by quantity equal to 25% of the required no. of taxis.
17. The taxis provided by the successful bidder shall be strictly in accordance with specifications and scope of works stated, any alterations of those conditions shall not be made without consent of DHS-NHM in writing. Any unauthorized deviation from the quality of the taxis as well as scope of works shall not be permitted.
18. Payment shall be released on monthly basis for taxis. The payment shall be released against submission of bill monthly along with copy of logbook/duty slip duly & GPRS DATA.
20. In case of any complaint by the user of the taxi, suitable penalty shall be imposed as decided by DHS-NHM.
21. The agency will ensure that there is enough fuel in the taxi and our officer should not be asked for cash for the same.
22. The Attested photocopy of Transport driving license of the drivers shall be submitted to us.
23. TDS as applicable will be deducted at source as per Income Tax Act.
24. The schedule and time communicated by DHS-NHM shall be strictly followed by the selected agency. In case of delay in executions of the order beyond the schedule time, DHS-NHM reserves the right to
 - a) Hire the taxi elsewhere at the cost and risk of the agency plus Rs. 1000/- per day shall be deducted from the bill as penalty.
 - b) Cancel the contract without prejudice to the right under (a) at above and also forfeit the earnest money/security deposit.
25. Conditional bids shall not be considered and will be outrightly rejected in very fast instance.

4. Settlement of Disputes

Amicable Settlement

The parties shall use their best efforts to settle amicably all disputes arising out of, or in connection with this Contract.

Arbitration:

If any dispute arises between the parties in connection with or arise out of, the Contract which is not resolved amicably within the period of 30 days, thereafter matter shall be referred to the Arbitration within two weeks by either of the parties under the provision of Arbitration and Conciliation Act, 1996.

The place of arbitration shall be, in concerned district of Uttar Pradesh. & the Arbitrator shall be District Magistrate of District Ambedkar Nagar.

5. Performance Security

The successful tender will have to deposit performance security of Rs. 5% of the project value in the form of Bankers cheque/Demand Draft/Bank Guarantee of reputed Bank, within 7 days from award of Contract along with Service Contract Agreement as in Annexure V. The performance bank guarantee should remain valid for a period of sixty days beyond the date of completion of all contractual obligations by the firm. In case the contract is further extended beyond the initial period, the performance bank guarantee will have to be accordingly renewed by the successful tenderer.

6. The Service Provider will indemnify DHS, NHM, District Ambedkar Nagar to the extent of direct damages against all claims, demands, costs, charges, expenses, award, compensations etc. due to Agencies violation of any patents and copy rights.
7. DHS, NHM, District-Ambedkar Nagar can terminate the Hiring of Taxi contract, for at anytime by giving one month notice for repeated breach of the Service Levels or Terms and Conditions, as provided in the Hiring Of Taxi Level Agreement, by the Service Provider.
8. FORCE MAJEURE: If the performance as specified in this order is prevented, restricted, delayed or interfered by reason of Fire, explosion, cyclone, floods, War, revolution, blockage or embargo, any law, order, proclamation, ordinance, demand or requirements of any Government or authority or representative of any such Government including restrictive trade practices or regulations.
