ट्रेड्स भुगतान संबंधी विवरण/TReDS Payment Details

This Bid provides for Trade Receivables Discounting System (TReDS) as Preferred mode of payment. For MSME sellers, payments may be processed through a TReDS exchange in which the Buyer is registered, subject to applicable policy and regulatory guidelines. Accordingly, sellers intending to

avail payment through TReDS are required to be registered with at least one TReDS exchange in which the buyer is registered.

1. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 30% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

If the buyer has mentioned MSE purchase preference in ATC then service provider is required to upload necessary documents for MSE purchase preference for verification by the buyer during evaluation.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

I. Eligibility Criteria: The cost of failed measurement or faulty measurement is very high with respect to production, cost and quality of end products.As such only those original manufacturers/vendors who satisfy following conditions are considered:

- Bidder has to be ISO 9001: 2015 certified MII qualified(Class I/ Class II) manufacturer of temperature tips or their authorized dealers.
- Vendors who have successfully supplied temperature tips since 1/1/2019 to ASP or any other SAIL units

OR

Vendors who have successfully supplied a minimum quantity of 15000 temp tips to any Government/ Public Listed company engaged in the manufacture of steel or other metals in India since 1/1/2019.

- Documents in support of above are to be provided by the vendor.

Note:

- SAIL reserves the right to verify any supporting document(s) submitted by a participating tenderer/bidder from its source(document issuing authority)
- In the interest of expeditious completion of verification, a participating tenderer/bidder shall provide a list of each supporting document on its letterhead as per "Annexure-S" along with the contact details (postal address, email address, landline/mobile number)of the issuing authority of each supporting document of verification
- Non-verification of any supporting document or information at the sole discretion of SAIL, does not absolve the tenderer/bidder of its absolute responsibility to provide only genuine document(s)in support of eligibility conditions.
- In case a supporting document or information is found to be fake/forged/tampered/non-genuine at any stage during tendering process and even after placement of purchase order/work order, the tenderer/bidder is liable for punitive actions as per extant guidelines of SAIL

II.Certificates and documents along with the techno commercial offer.

Copies of the following Certificates/ documents are required to be submitted with techno commercial bid as these are pre-requisite for considering the offer :-

- Latest letter of authorization from the original Thermocouple probes/ sensor/ insert manufacturer (OEM/Principal) authorizing the tenderer as official user of their Thermocouple probes/ sensor/ insert for producing Thermocouple probes assemblies and marketing of the same. The validity of the authorization shall be for minimum 1 (One) Year from the due date of opening of offers.

- ii. The valid ISO 9001:2015 or equivalent international standard certificate of the Temperature tips sensor/ insert manufacturer.
- iii. Relevant technical catalogues and drawings and photograph and details of visible/distinct, markings of manufacturers of temptips.
- iv. Certificate that the tenderer will be using inserts of international repute OEM/Principal having requisite facilities as mentioned in the specification document, for calibration and accuracy.
- v. Self-attested copy of the Certificate along with the photograph of sensors / inserts with distinctive identification mark from their OEM/Principal of Temperature tips/ sensors/ Insert, declaring the distinctive visible identification mark used by them on their sensor / inserts. The same identification mark shall be indicated in the LOA/ Purchase Order to correlate the supplies.
- vi. Other documents:
 - a) Udyam Certificate in case of MSE/DPIIT certificate for startup.
 - b) Bid Securing Declaration (Annexure-1 of ATC)
 - c) Non-Collusive Certificate.(Annexure-4 of ATC)

III. Certificates and documents along with each consignment

Supplier shall furnish the following along with each consignment:-

- i. Self-attested copy of Test Certificate by the OEM / Principal manufacturer of the sensor inserts for calibration results in Palladium bath at 1554 Deg.C.
- ii. Self-attested copy of Invoice for procurement of Insert from OEM /Principal
- iii. Self-attested copy of Country of origin certificate for inserts.
- iv. Declaration by the supplier for having used the certified sensor / inserts of their OEM / Principal with appropriate batch numbers in the manufacturing thermocouple tip assembly.
- v. Buyer's copy of Invoice / delivery challans.
- vi. Guarantee/Warranty certificate for performance and quality of workmanship against each consignment with the validity of 18 months from the date of supply. The whole consignment shall have to be replaced if found Defective or below quality norms as specified in the SAIL testing Procedure as per clause III below.

IV. Uniform Testing / Inspection Procedure for lots to be supplied :

- i. 10 (Ten) Nos. of thermo-couple tips with paper tube, randomly selected, shall be checked for continuity, ID, thickness and length of tube in each lot/consignment, and acceptance parameters shall be as under:
 - a. ID within +/- 0.2mm, thickness 7mm (min) and Length within +/- 1.0mm;
 - b. Continuity checking: 100% tips must pass continuity check
- ii. If the results are within above acceptable parameters, the temperature tips received in the lot/consignment will be put to regular use.
- iii. If the results are not within above acceptable parameters the party shall be informed for replacement of the lot/consignment.
- iv. After putting the tips for regular use, the performance of the tips shall be ascertained by the Operation/Instrumentation Deptt.If there is any complaint regarding the performance, the vendor would be called for redressal/ replacement of the lot/ consignment and will be subjected to test for comparison and repeatability (if required)

V.As per Preference to Make in India order, purchase preference will be applicable only for vendors having minimum 50 % local content, whereas participation in the current tender will be restricted to Class I and Class II vendors,i.e., vendors having minimum local content of 20%.

VI. **Staggered Delivery:** The ordered items shall be supplied in a staggered manner. Our requirement is material to be delivered in equal lots (each of 8500-9500 pcs) with first lot to be delivered within 45 days of placement of the contract and in subsequent lots within interval of 45 days from the receipt of preceding lot.

VII.**Packing and Marking:** In cardboard cartons containing 50 nos. of thermocouple tips.Details of packing and marking as per attached specification sheet.

VIII. **Risk Purchase** - If the supplier fails to deliver the stores either in full or in part, within the prescribed delivery period, the Purchaser shall be entitled at his option to take alternate procurement action, at the risk & cost of the supplier for the unsupplied portion of the goods/items for which delivery has expired without cancelling the contract in respect of stores not yet due for delivery, or to cancel the contract based on progress of work, including stores not due for delivery, and, if thought fit/ necessary, to purchase the stores at the risk and cost of the supplier. The price differential, in case of higher cost to SAIL, if any, shall have to be borne by the defaulting supplier. Moreover the defaulting supplier shall have no claim over the quantity, which they failed to supply.

IX. **Banning of Business Dealings:** On arising any situation or occurrence of any event as mentioned in Clause 6 of the Guidelines on Banning of Business Dealings available on SAIL Tender website (www.sailtenders.com), the tenderer/bidder or supplier under the tendering process or contract with SAIL, as the case may be, shall be liable for action under and in accordance with the aforementioned Guidelines. The "Guidelines on Banning of Business Dealings" shall form part of the Tender/Contract.

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel

the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate

action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
