If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

15. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Chinese origin product is not acceptable. A declaration of the same must be furnished by the bidder.
2. Bidder local office :- Bidder must have a functional office in Goa. The document proof for the same must be provided at the time of bidding.
3. Bid security declaration be submitted instead of EMD as per GOI/MOE letter no. F.9/4/2020-PPD dated 12 Nov 20.
4. Acceptance all additional terms & Condition to be declared by the bidder at the time of bidding.
5. Bidders are to upload all the requisite details of their offered products including brand details along with the technical documents at the time of bidding.
6. Bidder should have experience related to subject case in last three years.
7. Bidders are to mandatorily submit previous work completion certificate related to subject case.
