10.1	The scope of work involves "Providing services of 01 no. Hydraulic Excavator (3D) including cost of driver, fuel, lubricants, maintenance, etc. working 08 hours daily complete in all respect as per the satisfaction of EIC".
10.2	<b>The vehicle shall be driven by Contractor's representative(s) (Herein after called the driver) with valid driving license as per latest Transport/Motor Vehicle rules and the driver should not be changed frequently.</b>

It will be the sole responsibility of the driver that log book is filled up daily and there is no cutting/overwriting, if there is any cutting/overwriting the same shall be attested by the Officer In-charge i.e JE/SDE.
10.5	The vehicle should be in good working condition to run on roads and also sometimes on Kaccha road etc. Driver should not refuse to use vehicle on such roads.
10.6	<b>The rates in the schedule shall include the fuel / diesel charges, cost of all kinds of spares, all the charges like driver's salary, other allowances, traveling allowance, night duty allowance, all kinds of taxes, service charges, insurance., road permits etc., as applicable and other miscellaneous expenses.</b>

10.1 2	The vehicle driver and vehicle shall not leave the office premises without permission from the concerned officer.
10.1 3	If the vehicle fails during movement or not available for MCC's use for whatsoever reason within the contract period, immediate alternate arrangement should be made within Two Hours on same day. If contractor fails to arrange alternative vehicle, penalty shall be imposed @ Rs. 5000/- per day.
10.1 4	MCC shall not be responsible for any accident, damages and theft to the vehicle or for any illegal act of driver or any staff of contractor during the period of hire. The contractor shall be fully responsible for any loss damage to the vehicle and also liable to pay full compensation for any injury or any other loss to pedestrian.
10.1 5	If there are varying or conflicting provisions in the documents forming part of the contract, the Engineer-in-charge shall be the deciding authority with regard to the intentions of the provisions and his decision shall be final and binding on the contractor.

However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
