1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

5. **Buyer Added Bid Specific Scope Of Work(SOW)**

1) The vehicle shall be based at Dhola Jn. station under SSE-Signal-Dhola Jn. SSE-Signal-Dhola-Junction will be the consignee for the work and Engineer In-charge will be ADSTE - Dhola Junction. The vehicle with driver shall be available round the clock (24 hours) at the office of SSE-Signal-Dhola-Junction.

2)The contractor shall supply a TRUCK of 10 MT capacity in good and perfect working condition and shall be maintained in good condition throughout the period of validity of contract so as to ensure satisfactory service under the contract. Railway shall have the right to reject the truck if not found suitable for working as per above.

3)Vehicle should be in good condition. **It should not be older than two-year model.**

4)Tenderer shall necessarily indicate following regarding the offered vehicle: (a) Type of truck with brand (b) Carrying capacity (c) Year of model (d) Type of permit (e) Ownership (including copy of documents.) (f) Type of body

5)The rate shall include the following:

a) All maintenance expenditure of the vehicle, i.e. major and minor repairs required for good running of the vehicle, lubricants, all consumables & cost of fuel. b) Rates shall include salary and other charges of driver . c) Rate shall include payment of RTO, Labour Authorities, Local and Municipal Authorities, Taxes, Levies, Fees, Toll and all other charges, which are necessary for continuance of the service under the contract. d) Rate shall include hiring of vehicle for 24 Hours in a day.

6)Payment clause:

Payment shall be made on quarterly basis.

I. Unused Kms in a particular month as against the minimum guaranteed usage variant will be carried forward to the next month and additional Km if any in the next month shall be adjusted against this.

II. Month wise proper record should be maintained in Log book and verify by contractor and Railway representative.

III. However, the payment for the selected usage variant in a month will be paid every month. Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months.

IV. Other conditions will be as per GeM agreement.

7)The driver will not be entitled for any allowance for overtime, night halt & out station charges etc. for this vehicle.

conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
